Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, During the discussions with GST Department the Company reviewed and found that some of input tax credit provided by the suppliers are not in line with GST Act, due to fault of suppliers from whom the company has availed input tax credit in good faith, is not as per the GST Act.

The Company has taken conscious decision to repay the input tax credit availed from the suppliers and paid voluntarily the GST Tax plus penalty and interest thereon as per the GST Law to avoid any future litigation and better compliance of law.

Accordingly the Company has paid an amount of Rs.80,19,275/- (including Interest Rs.22,32,185 and Penalty Rs.7,54,838).

We bring to your kind notice that the Company has not received any notice or demand order from the GST authorities and the Company voluntarily paid the above said amount.

The required details under SEBI Circular no. SEBI/HO/CFD/CFDPoD-1/P/CIR/2023/123 dated July 13, 2023, are enclosed as Annexure A.
