UPDATE (JNPA)

Shri Sarbananda Sonowal, Hon'ble Union Minister of Ports, Shipping and Waterways, visits JNPA

Shri Sarbanand Sonwal, Hon'ble Union Minister of Ports, Shipping, and Waterways, visited Jawaharlal Nehru Port Authority (JNPA), India's best-performing Port, on Thursday, August 22, 2024, to inaugurate three lake beautification and rejuvenation projects in the JN Port vicinity. He also reviewed various infrastructure and developmental projects at the Port. On arrival at the Port Shri Unmesh Sharad Wagh, IRS, Chairman, JNPA welcomed Union Minister, MoPSW, Shri Sarbananda Sonowal. Highlighting JNPA's commitment to environmental sustainability, the Minister inaugurated three significant water bodies aimed at enhancing the ecological balance in the region. These include the Admin Building Foothill Lake and the CPP Lake, both of which are strategically located within the port vicinity, serving as vital reservoirs for rainwater harvesting and habitat restoration. The groundbreaking ceremony of the Jashkar Lake was also performed by him. These lakes are named after the great saints of Maharashtra Saint Dyaneshwar Maharaj, Saint Eknath Maharaj and Saint Namdeo Maharaj. During the visit, he also performed the groundbreaking ceremony for the Smart SEZ project. He planted a sapling under the Ek Ped Maa Ke Naam initiative at JNPA SEZ. The signing of two crucial Memorandums of Understanding (MoUs): one between JNPA, Vadhvan Port, and REC for the disbursement of loans to support various infrastructure projects, and another between Gateway Terminals India (GTI) and JNPA for the implementation of shore power supply for vessels, which underscores JNPA's dedication to sustainable port operations took place in the august presence of the minister.

UPDATE (UNIVERSITY OF MAINE)

Breakthrough Revolutionizes Sustainable and Biobased Packaging Pioneering Research by Dr. Pradnya D. Rao at the University of Maine Sets New Standards in Eco-Friendly Packaging. In the heart of what is now known as Nano Cellulose Valley, a groundbreaking development is taking shape that promises to revolutionize the packaging industry. Dr. Pradnya D. Rao successfully led the team at the University of Maine, United States, and is addressing one of the industry's

most critical challenges: achieving sustainability through biopolymers while significantly reducing costs. The persistent problem of plastic waste has long been a driving force behind the search for eco-friendly alternatives. Biopolymers such as starch, cellulose nanofibers (CNF), polylactic acid, and many more have emerged as potential solutions. Among these, CNF stands out due to its sustainable and natural derivation. However, its commercial use has been hindered by high water content and prolonged drying times, making it less viable for widespread application. Transporting CNF slurry, with such a low concentration of solid content, is not only inefficient but also costly, as the bulk of the weight being moved is water. This exceptional and extraordinary research was also presented as an wited talk at the International Conference on Nanotechnology for Renewable Materials in Helsinki, Filland. Dr.Rao's research represents a significant leap forward in our guest for a greener, more susainable future. As industries strive to reduce their environmental footprint, the advancements spean eaded by Dr.Rao and her team provide a beacon of hope. By harnessing the power of natural materias and innovative processes, the path toward sustainable and cost-effective biobased packaging is cleared than ever. The future of packaging, and indeed many other sectors, looks bright with nanocellulese leading the charge.

WR'S MAJOR BLOCK BETWEEN GOREGAON AND KANDIVALI

To facilitate the construction of the 6th line between Goregaon and Kandivali, a major block of 10 hours will be taken on the Up and Down slow lines between Goregaon and Kandivali stations from 22:00 hrs to 08.00 hrs during the intervening night of Saturday/ Sunday, i.e. on 31st August/01st September, 2024.
