Notice u/s 35 (3) of The Bharatiya Nagarik Suraksha Sanhita, 2023 dated 27th December 2024 has been issued by the Office of Special Cell (GS), Detective Department, Lalbazar Kolkata to Mr. Girish Siriram Juneja (RP), Ramchandra Parasam Une (Sinnar Plant Head) and Bharat Gupta (Partner, EY).

In our opinion, registration of an FIR does not warrant a disclosure under Regulation 30 of SEBI LODR Regulations as the same neither constitutes 'litigation' nor does it have an impact on the listed entity. However, the disclosure is being made in order to ensure good corporate governance.
