Dear Sir/ Madam,

Pursuant to Regulation 30 read with Para-A of Part-A of Schedule-III of the SEBI Listing Regulations, we hereby inform you that BSE Ltd ("BSE") has levied fine of Rs.35,400/- (incl. GST) on the Company for the non-compliance with submission of Annual Secretarial Compliance Report ("ASCR") in XBRL format under Regulation-24A for the year ended March, 2024.

The Company has clarified to BSE that the Company had filed ASCR both in PDF and XBRL format on May 16, 2024 with both the Stock Exchanges (BSE and NSE). However due to technical glitch with BSE portal for the XBRL on the day of filing, the XBRL format which was uploaded by the company might not be appearing on BSE portal.

Further, the Company has requested for the waiver of fine due to technical glitch, it is also clarified that the aforesaid was neither due to any negligence by the Company nor within the control of the Company and continuous efforts were also made to meet the compliance requirements.

The fine levied by BSE has been paid by the Company, this does not have any material impact on the financial, operation or other activities of the Company.

The details as required under SEBI Listing Regulations read with Circular no. SEBI/HO/CFD/CFD-PoD-1/P-CIR//2023/123 dated July 13, 2023 are enclosed as **Annexure I.**
