(f) Brief details of dispute / litigation: Industrial promotion Assistance treated as taxable income by the income tax department instead of capital receipt

Appellate Tribunal:

We would like to inform that the Company's appeal before ITAT on this subject matter has been successful for financial year 2013-14. ITAT vide its order dated 3rd July 2024, has allowed the appeal in Company's favour.

Further, the Income Tax Department has filed an appeal with ITAT on the said issue pertaining to financial year 2011-12 and 2012-13, which was earlier allowed by Commissioner of Income-Tax (Appeals). The Department's appeal was dismissed by ITAT vide its order dated 3rd July 2024.

Hence, the issue relating to the financial year 2011-12 to 2013-14 is resolved to the extent of Rs.37.93 Crores.

The said order was received by us on 4th July 2024.
