**Proceedings of the 48<sup>th</sup> Annual General Meeting**  
**of La Tim Metal & Industries Limited held on Saturday, 17<sup>th</sup> August, 2024**

The 47<sup>th</sup> Annual General Meeting of the Members of the Company was held on Saturday, August 17, 2024 at 3.30 P.M. through Video Conferencing (VC) / Other Audio Visual Means (OAVM) to seek the approval of members of the Company on resolutions set out in the Notice Convening Annual General Meeting.

Mr. Rahul Timbadia, Managing Director of the Company welcomed the shareholders of the company and the requisite quorum being present, he called the meeting to be in order.
