Shri Subodh Kumar Singh is not related to any other Director on the Board of NMDC Steel Limited. He is not disqualified to act as a Director under the provisions of Section 164 of the Companies Act, 2013. Further, he is not debarred from holding the office of Director by virtue of order of Court or Tribunal or SEBI or any other such authority.

<u>Brief Profile</u>: Shri Subodh Kumar Singh, Additional Secretary & Financial Advisor, Ministry of Steel, Government of India, belongs to the Indian Administrative Service (Chhattisgarh Cadre-1997).
