### PROCEEDINGS OF THE 30TH ANNUAL GENERAL MEETING OF RAJNISH RETAIL LIMITED (FORMERLY KNOWN AS 'SHEETAL DIAMONDS LIMITED') HELD ON TUESDAY, SEPTEMBER 24TH, 2024.

#### Date, Time and Venue of the Meeting:

The 30th Annual General Meeting ("AGM") of the Members of RAJNISH RETAIL LIMITED (Formerly known as 'Sheetal Diamonds Limited') (the "Company") was held today i.e. on Tuesday, 24th September, 2024 through Video Conferencing (VC)/Other Audio-Visual Means (OAVM) in accordance with the various circulars issued by the Ministry of Corporate Affairs and Securities and Exchange Board of India, from time to time.

The AGM had commenced at 02:09 p.m. and was concluded at 02:40 p.m. (IST) (including the Insta-poll).

#### Brief details of the items deliberated at the AGM and results thereof:

- Mrs. Apra Sharma, Independent Director of the Company requested Mr. Rajnish Kumar Singh, Chairman of the Company to commence the proceedings by addressing the shareholders.
- Mr. Rajnish Kumar Singh, Chairman, chaired the AGM and welcomed the shareholders to the 30th Annual General Meeting. The requisite quorum being present, the Chairman called the meeting to order.
- Mrs. Apra Sharma, Independent Director, explained the general instructions to the Members who had joined the meeting and introduced the Board Members present on the dais to the Members of the Company. Since Meeting was held through VC/OAVM there was no possibility of securing physical attendance of the Members and in line with the applicable guidelines, there was no requirement of appointing proxies as well. The Members were informed that that requisite document i.e. Statutory Registers, relevant documents referred to in the Notice of AGM were made available for inspection. As per the applicable laws, the Company had provided the facility of remote e-Voting which was kept open from Saturday, September 21, 2024 (09:00 a.m.) till Monday, September 23, 2024 (05:00 p.m.).

Item No. 2	To re-appoint Mr. Rajnishkumar S. Singh (DIN: 07192704) who retires by rotation & being
	eligible offers himself for re-appointment as Director.

- The Company had received requests from a few Members for registration as speaker at the AGM. However, no speaker shareholders were present at the AGM.
