Sub: Intimation regarding divestment of the Company's entire stake in Sirius Digitech International Limited, a wholly owned subsidiary of the Company.

Ref: Disclosure pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

We refer to our intimation dated 9th May, 2024 regarding execution of a Share Purchase and Shareholders' Agreement pursuant to which our wholly owned subsidiary Adani Global Mauritius ("Adani Global"), had acquired 49% stake in a UAE based entity named Sirius Digitech Limited ("Sirius Digitech"). Further as mentioned in the intimation, the said Shareholders' Agreement also contemplated that, as a part of transaction, the Company would divest its entire stake from its subsidiary in favour of Sirius Digitech.

Pursuant to the above, the Company has today i.e on November 14, 2024, executed a Share Transfer Agreement to divest its entire stake in Sirius Digitech International Limited ("SDIL") a wholly owned subsidiary of the Company. Upon completion of transfer of shares, SDIL will cease to be a subsidiary of the Company.
