Sub: Outcome of Circular Resolution passed by the Nomination, Remuneration and Compensation Committee

This is to inform you that the Nomination, Remuneration and Compensation (NRC) Committee of the Board by way of Circular Resolution on 26th December, 2024 have inter alia transacted the following business:

1. Approved allotment of 15,908 Equity shares of Rs.10 each under ESOP-2007 scheme and 39,423 Equity shares of Rs.10 each under ESOP-2018 scheme to the eligible employees of the Company on exercise of stock options vested in them.

Consequently, on allotment of equity shares under ESOP Scheme-2007 and ESOP Scheme-2018, the issued, subscribed and the paid-up Equity Share capital of the Company has increased from 2,49,61,693 Equity shares to 2,50,17,024 Equity shares of Rs.10 Each.
