We have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by **Infomedia Press Limited** (hereinafter referred as 'the listed entity'), having its Registered Office at First Floor, Empire Complex, 414- Senapati Bapat Marg, Lower Parel, Mumbai – 400013. 
