Material Event is not disclosed to the Exchange within 24 Hours. (submit reason for delay).

In reply of that, we hereby update the Exchange that we have replied the genuine reason of the delay in compliance for the said disclosure via email dated 2nd October, 2024.

We hereby inform the Exchange that the details as required pursuant to the SEBI Circular dated July 13, 2023 has already been filed with the Exchange. We have tried to file the said Compliance on Saturday, 28th September, 2024 as well as Sunday, 29th September, 2024, i.e. within 24 hours of the occurrence of an event. However, due to Technical issues facing with the Listing Center website while Login and post compliance work, the said Disclosure has been filed on 30th September, 2024.

We hereby confirm that the Company has been compliant with the filings to the Exchange on Regular basis. This was technical system issue which caused delay in filing, which was not intentionally done. We will due take care of the timely filings ahead.
