MANAGEMENT DISCUSSION AND ANALYSIS REPORT

1. OUTLOOK:

Global Outlook:

The global dyes and chemicals industry is undergoing significant transformation, with a projected market growth from USD 37.5 billion in 2023 to USD 46.2 billion by 2028, reflecting a compound annual growth rate (CAGR) of 4.4% (source: MarketsandMarkets). This growth is driven by several key factors:

- **Sustainability Trends:** There is a growing demand for sustainable and eco-friendly products. Consumers and industries are increasingly prioritizing environmentally responsible practices. Innovations in green chemistry, such as the development of biodegradable dyes and low-impact chemicals, are gaining traction. The global green chemistry market was valued at USD 12.8 billion in 2022 and is projected to reach USD 21.5 billion by 2027 (source: MarketsandMarkets).
- **Technological Advancements:** Technological advancements are reshaping the industry. Automation, digitalization, and advanced production techniques are enhancing efficiency, reducing costs, and improving product quality. The integration of AI and machine learning in manufacturing processes is expected to drive further innovation.
- **Regulatory Environment:** Stricter environmental regulations and standards are compelling companies to adopt more sustainable practices.

This includes reducing hazardous substances, minimizing waste, and improving energy efficiency. Regulations such as the EU's REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals) and similar frameworks globally are influencing market dynamics.

- **Market Dynamics:** The market is also experiencing increased competition due to the entry of new players and the consolidation of existing ones. The focus on sustainability is driving mergers and acquisitions as companies seek to expand their product portfolios and capabilities in eco-friendly solutions.

However, the industry faces challenges including:

- **Raw Material Price Volatility:** Fluctuating prices of raw materials, such as petrochemicals and other inputs, are impacting production costs and margins.
- **Supply Chain Disruptions:** The COVID-19 pandemic has highlighted vulnerabilities in global supply chains, causing delays and increasing costs related to logistics and transportation.

Indian Outlook:

In India, the dyes and chemicals sector is experiencing robust growth, with the market expected to grow at a CAGR of 6.8% from 2023 to 2028 (source: IMARC Group). The Indian chemical industry, encompassing dyes and pigments, was valued at approximately USD 178 billion in 2023 and is projected to reach USD 248 billion by

2028 (source: ChemAnalyst). Key factors influencing the Indian market include:

- **Government Initiatives:** The Indian government's Make in India program, coupled with various incentives for domestic manufacturing, is fostering growth in the sector. Initiatives like the Production Linked Incentive (PLI) scheme are designed to boost production and reduce reliance on imports.
- **Growing Domestic Demand:** Increasing industrial activities, especially in textiles, automotive, and consumer goods, are driving demand for dyes and chemicals. The rise in consumer spending and the expansion of end-use industries are contributing to market growth.
- **Focus on Sustainability:** The Indian market is also aligning with global sustainability trends. There is an increasing emphasis on green chemistry and sustainable manufacturing practices, driven by both regulatory requirements and consumer preferences.
- **Infrastructure Development:** Investments in infrastructure development and industrial parks are enhancing the sector's growth prospects. Improved logistics and supply chain infrastructure are expected to reduce operational costs and improve efficiency.

Company Outlook:

Shankar Lal Rampal Dye Chem Limited is strategically positioned to capitalize on these market trends. Our commitment to innovation and sustainability aligns with the evolving demands of the global and Indian markets. We are actively expanding our product portfolio to include eco-friendly and high-performance solutions, enhancing our

operational efficiency, and strengthening our market position. Our strategic initiatives are designed to leverage growth opportunities and address market challenges effectively, ensuring our continued success in the dynamic industry landscape.

2. INDUSTRY STRUCTURE & DEVELOPMENTS:

Industry Structure:

The structure of the dyes and chemicals industry is increasingly characterized by consolidation, technological innovation, and a shift towards sustainability. Key aspects of the industry structure include:

- **Consolidation:** There has been a trend towards consolidation within the industry, with mergers and acquisitions enabling companies to expand their product offerings, enter new markets, and achieve economies of scale. This consolidation is driven by the need to compete effectively and invest in advanced technologies.
- **Technological Advancements:** Technological innovation is a major driver of change in the industry. Advances in automation, digitalization, and smart manufacturing are improving production efficiency and product quality. Companies are investing in research and development to develop new formulations, enhance performance, and reduce environmental impact.
- **Sustainability Focus:** There is a strong emphasis on sustainability, with companies adopting green chemistry practices and developing eco-friendly products. This includes efforts to reduce the use of hazardous

chemicals, minimize waste, and improve energy efficiency. The adoption of sustainable practices is driven by regulatory requirements and growing consumer demand for environmentally responsible products.

Companies are investing in research and development to create biodegradable dyes, reduce water usage, and lower carbon emissions. The introduction of new regulations and standards has accelerated these efforts.
- **Regulatory Changes:** There have been updates to environmental regulations and standards, impacting manufacturing processes and product formulations. Compliance with new regulations requires companies to adapt their practices and invest in new technologies.
- **Market Dynamics:** The industry has experienced increased competition due to the entry of new players and the expansion of existing ones. Companies are focusing on differentiation through innovation, sustainability, and customer service to maintain a competitive edge.

- **Supply Chain Adjustments:** The disruptions caused by the COVID-19 pandemic have led to adjustments in supply chain strategies. Companies are diversifying their supply sources, enhancing inventory management, and adopting digital tools to improve supply chain resilience.

Shankar Lal Rampal Dye Chem Limited has actively engaged in these developments, investing in technology, sustainability, and compliance to enhance our market position and operational efficiency. Our strategic initiatives are aligned with industry trends and are designed to drive long-term growth and success.

3. Economic scenario:

India's dynamic economic landscape, bolstered by steady domestic demand and a strategic focus on industrial growth, presents significant opportunities for companies operating in the dyes and chemicals sector. The government's emphasis on manufacturing excellence, coupled with increased capital investments, has created a fertile ground for innovation and expansion. Shankar Lal Rampal Dye Chem Limited is well-positioned to leverage these opportunities, driven by our commitment to safety, sustainability, operational excellence, customer focus, and digitalization.

Our company has made strategic advancements in diversifying its product offerings, including a comprehensive range of organic and

inorganic specialty chemicals. These products cater to key industries such as Sanitization, Textile Dyeing, and Printing. Our trading facilities, strategically located in Bhilwara (Rajasthan) and Mumbai (Maharashtra), play a crucial role in our distribution network, ensuring efficient service across various markets. Both facilities are ISO 9001:2015 and ISO 14001:2015 certified, reflecting our dedication to maintaining the highest standards in quality management and environmental responsibility.

Over the past few years, we have embarked on a transformative journey, making significant investments in new product capabilities and enhancing our operational efficiencies. This transformation has enabled us to expand our product portfolio, innovate

in response to market demands, and strengthen our competitive position. Our efforts in sustainability are deeply integrated into our operations, as we strive to reduce our carbon footprint through energy-efficient practices and an increased reliance on renewable energy sources.

At Shankar Lal Rampal Dye Chem Limited, sustainability is not just a goal but a guiding principle that influences every aspect of our business. We are committed to ethical practices across our supply chain, working closely with suppliers to ensure responsible sourcing and production. By embedding sustainability in our operations, we aim to create long-term value for our stakeholders while contributing positively to the environment and society.

4. Key Ratios

As required by SEBI (LODR) (Amendment) Regulations, 2018, the Company is required to furnish the details of significant changes (i.e. change of 25% or more as compared to the immediately previous financial year) in key financial ratios based on standalone financial statement, along with detailed explanations for the changes. Kindly refer Page 6 for details.

Many Ratio show favorable trend as due to the product company deals in, has shown consistent demand in market. The turnover has shown a positive impact due to reasons stated in Business Outlook. Dividend Payout Ratio was favorably impacted as company decided to continue wealth sharing with its shareholders.



5. Major challenges & solutions:

1. Manufacturing Facility Not available - while our company offers a diverse range of dye color shades, the lack of an in-house manufacturing facility constrains our ability to serve a broader customer base and exacerbates competitive pressures. This limitation affects our ability to manage production costs and respond to the increasing market demand effectively. Though Trading allows us to remain agile, adapt quickly to market changes, and avoid the significant capital expenditure associated with manufacturing facilities. We are exploring the opportunities in manufacturing sector but still we are finding the industry is projected to grow at a CAGR of 5.1%, trading-focused companies like ours are well-positioned to benefit from this expansion.
2. Dependent on third-party suppliers - Shankar Lal Rampal Dye Chem Limited currently depends heavily on third-party producers for dye and chemical intermediates due to our lack of an in-house manufacturing facility. This dependency subjects us to risks such as price volatility, supply chain disruptions, and limited bargaining power. Over the past two years, fluctuations in raw material

prices and supply chain issues have led to cost increases of up to 30% for intermediates. While our strong business relationships and significant volume of business help mitigate some of these risks, the lack of direct control over the production process remains a critical challenge. The global chemical intermediates market, projected to reach USD 293 billion by 2027 with a CAGR of 4.5%, underscores the importance of securing a stable and cost-effective supply chain as competition intensifies.

3. Increasing competition - The dyes and chemicals industry is characterized by intense competition from both organized and unorganized players, with significant pressure on pricing and customer retention. Our company faces challenges in maintaining competitive pricing while ensuring product quality and customer satisfaction. The industry's low barriers to entry further exacerbate this issue, as new players can easily enter the market and disrupt established businesses.

Moreover, the potential resurgence of China's dye and chemical industry, which currently holds a commanding global market share of approximately 70%, could increase competition, particularly in terms of pricing and innovation. Despite these challenges, Shankar Lal Rampal Dye Chem Limited has demonstrated resilience by expanding its market share and maintaining strong customer relationships.

4. **Extreme volatility of exchange rate** - the volatility of the Indian rupee against the US dollar poses significant challenges, particularly due to our reliance on imported raw materials. Exchange rate fluctuations can lead to unpredictable cost structures, squeezing margins and affecting overall profitability. Over the past decade, the Indian rupee has depreciated by an average of 3-4% annually against the US dollar, with significant fluctuations in recent years due to global economic uncertainties. This volatility can be particularly challenging for companies in

the dyes and chemicals sector, where input costs are closely tied to global commodity prices.

5. Increase in Purchase Prices.

The company anticipates a substantial increase in purchase prices, material handling, and transportation costs, which will significantly elevate our inventory costs and potentially impact our profit margins. Global chemical prices have risen by an average of 10-15% over the past year, driven by supply chain disruptions, rising raw material costs, and increased transportation expenses. Managing these rising costs while maintaining competitive pricing will be crucial for sustaining our market position. According to recent data, logistics costs in India account for approximately 14% of GDP, which is higher than the global average of 8-10%. This discrepancy underscores the importance of optimizing supply chain operations to remain competitive in the global market.

6. Government Initiatives

The Indian government has introduced several initiatives to support the dyes and chemicals industry:

National Chemical Policy: Aims to enhance the sector's growth

and global competitiveness by promoting sustainable practices and innovation.

Production Linked Incentive (PLI) Scheme: Provides incentives for domestic manufacturing and reduces dependency on imports.

Streamlining Import Regulations: Efforts to simplify and expedite import procedures, reducing bureaucratic hurdles for businesses.

Support for R&D: Funding and support for research and development in sustainable and green chemistry.

7. Business outlook:

Shankar Lal Rampal Dye Chem Limited has successfully enhanced its business operations by focusing on product quality assurance and adhering to best trade practices. This strategy has allowed the company to trade in higher value products and expand capacities to an optimal scale. The company's emphasis on value-added chemical storage and efficient delivery processes reflects its commitment to maintaining high standards and meeting customer demands effectively.

The company has secured adequate banking facilities, including working capital limits,

from its bankers and lenders, which will support its operational needs and growth initiatives. This financial stability has been instrumental in reducing overall debt levels from the previous fiscal year, positioning the company favorably in terms of solvency, liquidity, and financial outlook.

For FY 2023-24, Shankar Lal Rampal Dye Chem Limited anticipates maintaining a strong financial position. The company's focus on sanitization chemicals, which are in high demand due to ongoing public health concerns, is expected to provide significant opportunities for growth. These products not only serve an essential role in public health but also present potential revenue streams that benefit both society and industry by mitigating virus-related risks.

To address the challenges of rising inventory costs, material handling charges, and the risk of bad debts, the company has implemented several measures. These include optimizing inventory management, negotiating better terms with suppliers, and enhancing credit control mechanisms. The company's strong solvency

position and disciplined financial practices ensure its ability to meet long-term and short-term debt obligations while maintaining timely interest payments and managing liabilities effectively.

2. Dividend

Considering the dividend history of the Company, liquidity and to ensure appropriate cover for market risk and to maintain a consistent level of dividend pay-out your Board of Directors recommends Final Dividend of Rs. 0.05/- (i.e. 0.50%) per Equity Share of Rs.10/- each, for the year amounting to Rs. 31.98 Lacs. The dividend payment rate is stable and similar to last year.

- In spite of increase in global competition and delays in global logistics; the total revenue of your co. is slightly reduced to Rs. 28,799.29 Lacs (Out of which Gross turnover from Business operations of Rs. 28,772.59 Lacs) recorded for the financial year 2023-24 from Last year Revenue which was 32,392.62 Lacs (Out of which Gross turnover from Business operations of Rs. 32,344.91 Lacs). Despite a slight reduction in revenue, Shankar Lal Rampal Dye Chem Limited remains optimistic about future prospects. The company anticipates improved opportunities ahead, even amidst current market slowdowns, volatile raw material prices, and rising logistics costs. This positive outlook is supported by the company's effective market strategies, its products' critical role in key industries, and the strong loyalty of its customer base. The company's proactive approach and strategic investments position it well to navigate these challenges and capitalize on emerging opportunities.
- The financial statements for the year ended on 31st March, 2024 show the profit of Rs.649.70 Lacs in FY 2023-24 as compared to Rs. 1,590.94 Lacs last year; there was a slight reduction in profits of 59.16% (YOY) this is due to slight decrease in revenue.

(c) Market Risk

Considering the Company's existing foothold/experience in the Textile sector, established & diversified client base, association with various international/domestic agents, it's competent sales team and an established marketing setup in India and International Market, it does not foresee any problem in marketing its production.

Market Risk is the risk of loss of future earnings, fair values of future cash flows that may result from a change in the price of a financial instrument. The value of a financial instrument may change as a result of changes in the interest rates, foreign currency exchanges rates, equity prices and other market changes that effect market risk sensitive instruments. Market risk is attributable to all market risk sensitive financial instruments including investments and deposits, and other market changes. The Company manages market risk through a finance department, which evaluates and exercises independent control over the entire process of market risk management. The finance department recommends risk management objectives and policies, which are approved by Senior Management and the Audit Committee. The activities of this department include management of cash resources, implementing hedging strategies for foreign currency exposures, borrowing strategies, and ensuring compliance with market risk limits and policies.

i) Interest Rate Risk

It is the risk where changes in market interest rates might adversely affect the company's financial condition. The short term/immediate impact of changes in interest rates are on the Company's net interest income/expenses. On a longer term, change in interest rate impact the cash flows on the assets, liabilities and off-balance sheet items, giving rise to a risk to the net worth of the Company arising out of all reprising mismatches and other interest rate sensitive positions.

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rate. In order to optimize the Company's position with regards to interest income and interest expenses and to manage the interest rate risk, treasury performs a comprehensive corporate interest rate risk management by balancing the proportion of fixed rate and floating rate financial instruments in its total portfolio.

1. Visit the e-Voting website of NSDL. Open web browser by typing the following URL: <https://www.evoting.nsdl.com/> either on a Personal Computer or on a mobile.
