देश स्वांतत्र्य होण्यापूर्वी सर्वप्रथम इंग्रजी जुलमी राजसत्तेला नामोहरम करून १६ ऑगष्ट १९४२ ला स्वातंत्र्य होण्याचा मान चिमूरला आहे. मात्र, हे स्वातंत्र्य चिमूरवासींना केवळ तीन दिवस उपभोगता आले. १९ तारखेपासून इंग्रजी सैन्यांनी चिमूर गावात धुडघूस घालत महिला, पुरुषांना सतत आठ दिवस अतोनात जुलूम केला. मात्र, या जुलुमांची बाहेर वाच्यता होऊन देशभर असंतोष वाढू नये म्हणून भारतीय संरक्षण नियम लागू करून प्रेसबंदी घोषित केली. ज्यामुळे चिमूर विषयीच्या वृत्तांकनास व प्रसिद्धीवर बंदी होती.

शासनपुरस्कृत अन्याय, अत्याचार जगाला कळू नये म्हणून अनेक वर्षांपासून जगातील अनेक राजसत्ता प्रसार माध्यमांना अशा क्षेत्रात प्रवेश, वृतांकन तथा प्रसिद्धीवर बंदी घालण्याची प्रथा अनेक वर्षापासुन रूढ आहे. भारत देश स्वंतत्र्य होण्यापुर्वी भारतीय संरक्षण नियम लागू करून इंग्रजी राजवटसुद्धा निर्बंध आणत होती. ८२ वर्षांपुर्वी ९ ऑगष्टला महात्मा गांधी यांनी मुंबईच्या ग्वालियर टॅंक मैदानातून इंग्रज राजवटील चले जाव चा इशारा दिला. तसेच देशवासींना स्वांतत्र्याकरिता करो या मरो असे आवाहन केले. हे लोण चंद्रपूर जिल्ह्यातील चिमूर येथेही पोहचले. यात भर राष्ट्रसंताच्या क्रांती भजन कीर्तनाने घातली. ज्याने या लहानशा गावातील क्रांतिवीरांत स्फुरण चढले. १६ ऑगष्ट नागपंचमीच्या दिवशी मिरवणूक काढण्यात आली. याचे नेतृत्व करणारयांना अटक केली व

मिरवणुकीवर लाठीचार्ज आणि गोळीबार केला. ज्यात वीर शहीद झाले. यानंतर अंसतोष वाढून नागरिक व इंग्रजी पोलिसांत धुमश्चक्री झाली. ज्यात इंग्रजी अधिकारयांना यमसदनी पाठविण्यात आले. क्रांतिवीरांनी इंग्रजी हायजॅक उतरवून तिरंगा फडकवला. १६ ऑगष्टला

चिमूर स्वतंत्र झाला व हे स्वांतत्र्य तीन दिवस टिकले. चिमूरच्या क्रांतिसंग्रामाची माहिती चंद्रपूर जिल्हाधिकारी सुब्रमन्यम यांना होताच १९ ऑगष्टला ४२ गाड्यातून ब्रिटीश फौजफाट्यासह चिम्रला येऊन डागबंगला, पोलिस स्टेशन व दवाखान्याची पाहणी केली. क्रांतिवीरांनी बंदी केलेल्या अधिकारयांची सुटका केली. या दिवसापासून तर २६ ऑगष्टपर्यंत सतत आठ दिवस चिमूर गावात मानवतेला लाजवेल असा ब्रिटिश सैनिकांचा सैतानी तांडव सुरू झाला. ज्यात लुटपाट, बलात्कार, अमानुष मारहाण तथा सामूहिक दंड वसूल करण्यात आला. याची बाहेर वाच्यता होऊ नये म्हणून भारत संरक्षण नियम लावून प्रेसबंदी लागू केली. त्यामुळे चिमूर येथे पत्रकारांना प्रवेश, वृत्तांकन व प्रसारणास बंदी घालण्यात आली. तरिही मुंबईच्या स्वांतत्र्य सेनानी उषा मेहता यांनी मुंबईच्या काँग्रेस रेडिओवरून अत्याचारास वाचा फोडली होती. प्रेसबंदी उठवण्याकरिता प्रा. जे. पी. भन्साळी सेवाग्राम येथील जमनालाल बजाज यांच्या घरी उपोषणास बसले. ज्यामुळे सरकारने कठोर नियम करीत चिमूर व भन्साळी यांच्या नामोल्लेख करण्यास बंदी

घातली. ६ ऑगष्ट १९४३ ला भारतीय प्रेसने याचा निषेध करण्याकरिता एकदिवसीय संप पुकारला. मात्र, ब्रिटीश सरकार व सीपी सरकार नरमले नाही. अत्याचाराच्या तब्बल सव्वा वर्षांने १२ जानेवारी १९४३ ला सीपी सरकार आणि प्रा. भन्साळी यांच्यात समझोता होऊन

प्रेस बंदी उठवण्यात आली.
