## Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) **Regulations, 2015 ("LODR Regulations")**

With reference to our earlier disclosure dated 1<sup>st</sup> May, 2024, wherein we had informed that the Securities and Exchange Board of India ("SEBI") issued an Adjudication Order no. ORDER/BM/RK/2024-25/30315 dated 30th April, 2024 ("Order"), under Section 15-I of the SEBI Act, 1992, read with Rule 5 of SEBI (Procedure for Holding Inquiry and Imposing Penalties) Rules, 1995. This Order imposes a penalty of INR 5,00,000 (Indian Rupees Five Lakhs only) on the Company for alleged violation of provisions of the LODR Regulations.

Further, we had informed that the Company is currently evaluating the aforementioned Order in consultation with its legal advisors. In this regard, we wish to inform you that the Company has today filed an appeal with the Hon'ble Securities and Appellate Tribunal ("Hon'ble SAT") against the aforementioned Order. Any material developments in this regard will be disclosed to you with reference to and in continuation of this disclosure.
