- Subsequent to the quarter ended September 30, 2024 Ambuja Cements Limited (the "Acquirer"), entered into Share Purchase Agreements ("Agreements") with the promoter group and certain other shareholders on October 22, 2024 pursuant to which, the Acquirer shall obtain 46.80% of the shareholding of the Company subject to the approval from Competition Commission of India (CCI) and other terms and conditions as set out in the Agreements. Pursuant to the completion of the underlying transaction in accordance with the provisions of the Agreement, the Acquirer shall hold 46.80% of the voting share capital of the Company. The Acquirer has made a public announcement of its intent to open offer for acquisition of up to 5,34,19,967 fully paid-up equity shares having a face value of INR 1 of the company, representing 20% of the share capital on a fully diluted basis from the eligible public shareholders of the company in compliance with the requirements of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, and subsequent amendments thereto.
