इंडियन मेडिकल एसोसिएशन (आइएमए) ने कोलकाता के एक सरकारी मेडिकल कालेज एवं अस्पताल में एक महिला चिकित्सक से बलात्कार और हत्या के मामले की जांच पूरी करने के लिए शनिवार को अधिकारियों को 48 घंटे का अल्टीमेटम दिया और चेतावनी दी कि अगर इस अवधि के भीतर दोषियों को गिरफ्तार नहीं किया गया तो वे देशव्यापी विरोध प्रदर्शन करेंगे।

## किशोरी से बलात्कार का आरोपी गिरफ्तार

ठाणे, 10 अगस्त (भाषा)।

नवी मुंबई पुलिस ने एक व्यक्ति को पड़ोस में रहने वाली किशोरी से बार-बार बलात्कार करने और उसे गर्भवती करने के आरोप में गिरफ्तार किया है।

एपीएमसी पुलिस थाने के एक अधिकारी ने बताया कि शिकायत के आधार पर शुक्रवार को भारतीय दंड संहिता और यौन अपराधों से बच्चों के संरक्षण (पाक्सो) अधिनियम के संबंधित प्रावधानों के तहत मामला दर्ज किया गया।
