We invite your kind attention that the in-principle approval is granted by BSE Limited vide letter dated October 12, 2023 and National Stock Exchange of India Limited vide letter dated October 11, 2023.

In this context we wish to inform you that the Stakeholders Relationship Committee of the Company on June 14, 2024, has approved allotment of 650 Equity Shares of the face value of ₹ 10 each under the ESOP Scheme to the eligible employees pursuant to exercise of stock options at an exercise price of ₹ 480 per share.
