Over 2.21 lakh participate in 3,619 co-op training programmes of NCCT in FY24

Mumbai: The National Council for Cooperative Training (NCCT), tasked with upskilling and empowering cooperative societies, built on a record-breaking year in 2022-23 by achieving even greater success in 2023-24. The NCCT surpassed its accomplishments from the previous year in all areas, including the number of training and awareness programs conducted, the number of participants trained, and the use of social media to raise awareness about Government of India initiatives, programs, and new ventures. This highlights the NCCT's commitment to empowering cooperatives and their stakeholders.

It conducted 3,619 training programs across the country during the financial year 2023-24, surpassing

its target of 3,140 by 15.25 per cent. During the financial year ending March 31, 2024, the NCCT trained 2,21,478 people associated with cooperatives in the country, registering a 10.78 per cent increase over the target of 2,00,000 participants.

The NCCT, an autonomous Society promoted by Union Ministry of Cooperation, is responsible for organizing cooperative training with focus on cooperative management and administration for the personnel working in the cooperative sector.

"After recording highest ever achievement on all fronts in the year 2022-23, the efforts of NCCT have resulted in surpassing the same during 2023-24 - be it in terms of number of training and awareness programmes conducted, or number of participants trained, or use of social media for spreading the awareness among masses about the Government of India's schemes, programmes and new initiatives," said a senior official of NCCT.

During 2022-23, the

NCCT had conducted 3,287 training programmes across the country against the target of 1,740 programmes. The number of participants stood at 2,01,507 compared to the target of 43,500. The NCCT official further said that during 2023-24, out of the total participants, 70,169 (31.68 per cent) were women who attended the training and awareness programmes.

X platform now has 600 million monthly active users: Musk

New Delhi, May 24 (IANS) Tesla CEO Elon Musk on Friday said that his X social media platform has reached 600 million monthly active users (MAUs). Musk, who acquired the platform in 2022 for \$44 billion, is making it an "everything app" where people can post movies and TV shows and also make digital payments.

"X has 600 million monthly active users, about half of which use the platform every day," the tech billionaire said in a post. The X users reacted, saying it is the best platform on earth. Super chats will also arrive for live content on X soon, according to Musk. Paid users can also post movies, TV series, or podcasts on the platform and earn money.

Musk has also informed his followers that the 'AI Audiences' feature is coming soon.

According to him, AI systems will generate a pool of the most relevant X users to target in seconds for the posts. The X owner recently announced that new users may soon be charged for posting content on the social platform. "Current AI (and troll farms) can pass 'are you a bot' with ease," Musk had posted.

Samsung to hold 'Galaxy Unpacked' in July in Paris: Report

Seoul, May 24 (IANS) Samsung Electronics is expected to hold the summer edition of its 'Galaxy Unpacked' event next month in Paris, the host of the upcoming Olympic Games, industry sources said on Friday.

The event will take place on July 10, just about two weeks before the opening of the Paris Summer Olympics, with the foldable Galaxy Z Fold 6 and Galaxy Z Flip 6 smartphones and the wearable Galaxy Ring to be unveiled, according to the sources. It is the second time that the world's biggest smartphone maker has released its new foldable products in July, following last year's Unpacked event in Seoul, reports Yonhap news agency. Previously, the company held its biannual Unpacked events in January and August.

Moreover, Samsung Electronics, an official partner of the International Olympic Committee, has chosen Paris as the venue for its summer edition ahead of the quadrennial world sporting event in the French capital. The new Galaxy Z series smartphones are expected to feature on-device AI, similar to the latest Galaxy S24 model, which was released in January.

Hackers continued to use malware, tools in Q1 that let their operations go undetected: Report

New Delhi, May 24 (IANS) Hackers continued to utilise malware and increasingly relied on tools with legitimate uses that allowed cybercriminal operations to go undetected for longer in the first quarter (Q1) of this year, a new report showed on Friday.

In its Q1 2024 Crimeware Report, the global cyber risk management company Arete showed that median ransom payments rose slightly from Q4 to Q1 but remained about the same as the median payments for all of 2023. "This report highlights the importance of vigilance and collaboration in the face of ransomware and extortion attacks," said Chris Martenson, Arete's Chief Data Officer. According to the report, throughout Q1, law enforcement continued to pressure large RaaS (Ransomware-as-a-Service) groups, significantly disrupting LockBit's operations.
