### Summary of the proceedings of the Extra-Ordinary General Meeting

The Extra Ordinary General Meeting (EGM) of the members of the Mafia Trends Limited ("the Company") was held on Friday, June 07, 2024at 12:30 PM at the registered office of the Company situated at 1, Prabhu Kutir Complex, Sandesh Press Road, Vastrapur, Ahmedabad, Gujarat, 380015.

Total number of shareholders as on the cut-off date i.e. May 31, 2024 were 175. Total 5 members attended the meeting at the venue. The Company has not received any request from members to appoint proxies.

Mr. Rajendra Singh Rajpurohit, Managing Director of the Company has chaired the meeting. The requisite quorum being present, the Managing Director called the meeting in order and welcomed the shareholders and other invitees present at the EGM. All Directors, KMPs, Statutory Auditors, and the Scrutinizer were present at the EGM.
