

 / herself and proxy need not be a member of the Company. Pursuant to Section 105 of Companies Act, 2013 a person can act
 as a proxy on behalf of members not exceeding fifty and holding in the aggregate not more than ten percent of the total share
 capital of the Company carrying voting rights. A member holding more than ten percent of the total share capital of the Company
 carrying voting rights may appoint a single person as a proxy and such person shall not act as proxy for any other person or
 shareholder/member.
- Proxies, in order to be effective, the proxy form should be duly stamped, completed, signed and must be sent to the Company so
 as to receive at its Registered Office not later than 48 hours before the commencement of the 39th AGM. A Proxy form is annexed
 to this report.
- Corporate members intending to send their representatives to attend the meeting are requested to send to the Company a certified copy of the board resolution authorizing their representative to attend and vote on their behalf at the meeting.
- 4. The members / proxies are requested to bring duly filled attendance slip enclosed herewith.
- 5. In line with the MCA's General Circular no. 20/2020 dated May 5, 2020 read with General Circular no. 02/2021 dated January 13, 2021, General Circular no. 02/2022 dated May 05, 2022, General circular no. 10/2022 dated December 28, 2022 & General circular no. 09/2023 dated September 25, 2023 and SEBI Master Circular dated July 11, 2023 read with Circular dated October 07, 2023; the Notice of the 39th AGM alongwith the Annual Report for the Financial Year 2023-24 is being sent only through electronic mode to those Members whose Email ID are registered with the Company/RTA/Depositories. A copy of the Notice of this AGM alongwith the Annual Report is available on the website of the Company at www.creative-cast.com and website of the Stock Exchange where the equity shares of the Company are listed, i.e. BSE Limited at www.bseindia.com. For any communication, the Members may also send a request to the Company's Email ID: info@creative-cast.com. The Company will not be dispatching physical copies of the Annual Reports for the Financial Year 2023-24 including Notice of AGM to any Members.
- Trading / Transfer/ Transmission / Transposition in the shares of the Company shall compulsorily be done in dematerialized form only. Pursuant to SEBI Press Release No. 12/2019 dated March 27, 2019, SEBI had clarified that the investors may continue to hold such shares in physical form even after the 1st April, 2019 subject to condition that investor who is desirous of transferring

shares (which are held in physical form) after April 01, 2019 can do so only after the shares are dematerialized. Shareholders are therefore advised to dematerialize your physical shareholding at the earliest, if not yet done. A procedure for dematerialization of shares of the Company is hosted on its website i.e. www.creative-cast.com. Dematerialization would facilitate paperless trading through state-of-the-art technology, quick transfer of corporate benefits to members and avoid inherent problems of bad deliveries, loss in postal transit, theft and mutilation of share certificate and will not attract any stamp duty. It also substantially reduces the risk of fraud. Hence, we request all those members who have still not dematerialized their shares to get their shares dematerialized at the earliest.

- Process for registration / updation, pertaining to the name, postal address, E-mail ID, telephone/mobile numbers, Permanent Account Number (PAN), mandates, nominations, power of attorney, bank details such as name of the bank and branch details, bank account number, MICR code, IFSC code, etc.:
 - i. In case shares are held in physical mode, members are requested to submit their service requests in the formats prescribed under SEBI Master Circular for Registrars to an Issue and Share Transfer Agents bearing no. SEBI/HO/MIRSD/POD-1/P/CIR/2024/37 dated 7th May, 2024. The form(s) are available on the website of the Company at https://www.creative-cast.com/Reports/Investorsdetailsupdationguideline.PDF and on the website of Company's RTA at https://liiplweb.linkintime.co.in/KYC-downloads.html.
 - ii. In case shares are held in electronic mode, members are requested to update details with their respective Depository Participants.
- Members holding shares in single name and physical form are advised to make nomination in respect of their shareholding in the Company. The members who are desirous of availing this facility, may kindly write to Company's R & T Agent for nomination form by quoting their folio number.
- 9. Members holding the shares in physical mode are requested to notify immediately for change of their address and bank particulars to the Company or its share transfer agent and in case their shares are held in dematerialized form then information should be passed on directly to their respective depository participants and not to the Company/Share transfer agents without any delay. Members are further requested to complete necessary formalities with regard to their Bank accounts attached to their Demat account for enabling the Company to make timely credit of dividend in respective bank account.
- 10. In compliance with the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), the Company is providing the facility of remote e-voting to its members in respect of the businesses to be transacted at the 39th AGM. For this purpose, the Company has availed the services of Central Depository Services (India) Limited (CDSL).
- 11. To increase the efficiency of the e-voting process, SEBI, vide Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023, intended to enable e-voting to all the demat account holders by way of a single login credential, through their demat accounts / websites of Depositories / Depository Participants. Demat account holders should be permitted to cast their votes without having to register again with the e-voting service providers, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process. As required by this Circular, Individual shareholders holding securities in demat mode are allowed to vote through their demat accounts maintained with Depositories and Depository Participants. Hence, members are advised to update their mobile numbers and Email IDs in their respective demat accounts to access e-voting facility.
- 12. The voting period begins on September 24, 2024, 09.00 AM and ends on September 27, 2024 at 05.00 PM. During this period members of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date (record date) of September 21, 2024 may cast their vote electronically. The remote e-voting module shall be disabled by CDSL for voting thereafter. A person who is not a member as on the cut-off date should treat this Notice for information purposes only. The information with respect to Voting process and other instructions regarding remote e-voting are detailed in Note no. 36.

The voting rights of the members shall be in proportion to the paid-up value of their shares in the equity capital of the Company as on the **cut-off date** i.e. Saturday, September 21, 2024.

- 13. The members who have cast their vote by remote e-voting may also attend the 39th AGM but shall not be entitled to cast their vote again. The member who votes through both, i.e, remote e-voting and also at 39th AGM through ballot / polling papers, the votes casted through remote e-voting shall prevail and counted for the purpose of declaration of result. Members who have not cast their vote using remote e-voting facilities and are attending the 39th AGM of the Company will be provided with an option to cast their vote using ballot / polling papers.
- 14. A person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date i.e. September 21, 2024 only shall be entitled to avail the remote e-voting facility as well as voting through ballot in the 39th AGM.

- 15. CS Mayur Buha, proprietor of M. Buha & Co., Practicing Company Secretary (Membership No. F9000) has been appointed as the scrutinizer to scrutinize the e-voting & poll (ballot) process in a fair and transparent manner.
- 16. The Scrutinizer shall, immediately after the conclusion of voting at the 39th AGM, count the votes cast at the meeting and there after unblock the votes cast through remote e-voting in the presence of at least 2 witnesses not in employment of the Company. The Scrutinizer shall submit a consolidated Scrutinizer's Report of the total votes cast in favour of or against, if any, not later than 2 working days from the conclusion of the 39th AGM to the Chairman of the Company. The Chairman, or any other person authorized by the Chairman, shall declare the result of the voting forthwith. The result declared along with the consolidated Scrutinizer's Report will be placed on the Company's website www.creative-cast.com and on the website of Central Depository Services Limited (CDSL) immediately after the result is declared by the Chairman and the same shall be simultaneously placed on the website of BSE Limited i.e. www.bseindia.com and will also be displayed for at least three days on the Notice Board of the Company at its Registered Office.
- 17. The resolution(s) shall be deemed to be passed on the date of 39th AGM, subject to the receipt of sufficient votes.

Notes on Dividend

- 18. Members may note that the Board of Directors, in its meeting held on August 10, 2024 has recommended a final dividend of Rs. 10.00 per equity share (i.e. 100%) for the financial year ended March 31, 2024. The "record date", for determining the eligibility of members to receive the dividend, will be September 21, 2024. The final dividend, once approved by the members in the ensuing 39th AGM will be paid within 30 days of the conclusion of the 39th AGM electronically through various online transfer modes to those members who have updated their bank account details. For members who have not updated their bank account details, dividend warrants / demand drafts / cheques will be sent out to their registered addresses in due course. To avoid delay in receiving the dividend, members are requested to update their KYC with their depositories (where shares are held in dematerialized mode) and with the Company's Registrar and Transfer Agent namely Link Intime India Pvt. Ltd. ("RTA") (where shares are held in physical mode) to receive the dividend directly into their bank account on the payout date.
- 19. Please note that SEBI has mandated that the security holders holding securities in physical form, whose folio(s) do not have the prescribed KYC, shall be eligible for any dividend payment in respect of such folios, only through electronic mode with effect from 1st April 2024, only upon furnishing all the mentioned details. Therefore, Members holding shares in physical form are requested to update the prescribed details by completing the appropriate ISR forms with the Company's RTA by Monday, September 16, 2024, to ensure receipt of dividend.

20. Members may note that the Income Tax Act, 1961, ("the IT Act") as amended by the Finance Act, 2020, mandates that dividends paid or distributed by a Company after April 01, 2020 shall be taxable in the hands of members. The Company shall therefore be required to deduct tax at source (TDS) at the time of making the payment of final dividend. In order to enable us to determine the appropriate TDS rate (Withholding tax rate) as applicable, members are requested to submit the following documents in accordance with the provisions of the IT Act.

For resident shareholders ("members"), taxes shall be deducted at source under Section 194 of the IT Act as follows

Members having valid PAN	10%*	No document required (if no exemption is sought)

^{*} As per the Finance Act, 2021, Section 206AB has been inserted effective July 1, 2021, wherein higher rate of tax (twice the specified rate) would be applicable on payment made to a shareholder who is classified as 'Specified Person' as defined under the provisions of the aforesaid Section or if the Permanent Account Number (PAN) is not linked to Aadhaar.

However, no tax shall be deducted on the dividend payable to a resident individual if the total dividend to be received by them during Financial Year 2024-25 does not exceed Rs. 5,000 and also in cases where members provide Form 15G (applicable to any person other than a Company or a Firm)/ Form 15H (applicable to individuals aged 60 years or more) subject to conditions specified in the IT Act. Resident members may also submit any other document as prescribed under the IT Act to claim a lower / Nil withholding tax. Registered members may also submit any other document as prescribed under the IT Act to claim a lower / Nil withholding tax. PAN is mandatory for members providing Form 15G / 15H or any other document as mentioned above.

For non-resident members, taxes are required to be withheld in accordance with the provisions of Section 195 and other applicable sections of the IT Act, at the rates in force. The withholding tax shall be at the rate of 20% (plus applicable surcharge and cess) or as notified by the Government of India on the amount of dividend payable. However, as per Section 90 of the IT Act, non-resident members have the option to be governed by the provisions of the Double Tax Avoidance Agreement (DTAA) between India and the country of tax residence of the member, if they are more beneficial to them. For this purpose, i.e. to avail the benefits under the DTAA, non-resident members will have to provide the following:

- Copy of the PAN card allotted by the Indian Income Tax authorities duly attested by the member or details as prescribed under rule 37BC of the Income-tax Rules, 1962.
- Copy of Tax Residency Certificate (TRC) for the FY 2024-25 obtained from the revenue authorities of the country of tax residence, duly attested by the member.
- · Self-declaration in Form 10F.
- · Self-declaration by the members of having no permanent establishment in India in accordance with the applicable tax treaty.
- Self-declaration of beneficial ownership by the non-resident members.
- . Any other documents as prescribed under the IT Act for lower withholding of taxes if applicable, duly attested by the member.

In case of Foreign Institutional Investors / Foreign Portfolio Investors, tax will be deducted under Section 196D of the IT Act at the rate of 20%** (plus applicable surcharge and cess) or the rate provided in relevant DTAA, read with MLI, whichever is more beneficial, subject to the submission of the above documents, if applicable.

** As per the Finance Act, 2021, Section 206AB has been inserted effective July 1, 2021, wherein higher rate of tax (twice the specified rate) would be applicable on payment made to a shareholder who is classified as 'Specified Person' as defined under the provisions of the aforesaid section. However, in case a non-resident shareholder or a non-resident Foreign Portfolio Investor (FPI) / Foreign Institutional Investor (FII), higher rate of tax as mentioned in Section 206AB shall not apply if such non-resident does not have a permanent establishment in India.

- 21. Documents (duly completed and signed), as envisaged above, shall be sent to the Company on its e-mail info@creative-cast.com or uploaded (at appropriate weblink provided in the e-mail) on the website of Link Intime India Private Ltd on or before September 18, 2024 in order to enable the Company / RTA to determine and deduct appropriate TDS / Withholding Tax. Incomplete and / or unsigned forms and declarations will not be considered by the Company. No communication on the tax determination / deduction shall be considered after September 18, 2024, 6:00 PM. The Company will arrange to email a soft copy of TDS certificate to members on their registered Email ID.
- 22. Members may note that in case the tax on said final dividend is deducted at a higher rate in absence of receipt of the aforementioned details/documents, option is available to them to file the return of income as per Income Tax Act, 1961 and claim an appropriate refund, if eligible.
- 23. In the event of any income tax demand (including interest, penalty, etc.) arising from any misrepresentation, inaccuracy or omission of information provided / to be provided by the Member(s), such Member(s) will be responsible to indemnify the Company and also, provide the Company with all information / documents and co-operation in any appellate proceedings.
- 24. This Communication is not exhaustive and does not purport to be a complete analysis or listing of all potential tax consequences in the matter of dividend payment. Members should consult their tax advisors for requisite action to be taken by them.
- 25. All communications/queries in this respect to dividend should be addressed to our RTA, Link Intime India Private Limited on their e-maid ID given in the e-mail communication.
- 26. The members who have not encashed their Dividend Warrants / Cheques / DD for any previous period are requested to send the same for revalidation to the Company at its registered office.
- 27. In terms of Section 124 and 125 of the Companies Act, 2013, any dividend, remaining unpaid or unclaimed for a period of seven years from the date of transfer of such dividend to Unpaid Dividend Account of a company shall be transferred by the Company along with interest accrued, if any, to the Fund established known as Investors' Education and Protection Fund (IEPF). Accordingly, the unpaid or unclaimed dividend, if any, for the financial year 2016-17 shall be transferred to the Investor Education and Protection Fund Account. Members, who have not encashed their dividend warrant so far, for the financial year 2017-18 and the subsequent years, are requested to make their claims at the Registered office of the Company. It may be noted that once the unclaimed dividend is transferred to the IEPF as above, no claim shall lie against the Company or the said fund in respect of any amounts which were unclaimed / unpaid for a period of seven years from the dates that they are transferred to Unpaid Dividend Account of the Company and no payment shall be made in respect of any such claims.

Further, pursuant to Section 124 of the Act read with the IEPF Rules; all shares on which dividend has not been paid or claimed for seven consecutive years or more shall be transferred to IEPF Authority as notified by the Ministry of Corporate Affairs.

- 28. The Securities and Exchange Board of India (SEBI) has mandated the submission of Permanent Account Number (PAN) by every participant in securities market. Moreover, SEBI has also mandated to provide bank details, in addition to PAN, of securities holders who holds shares of the Company in physical form. Members holding shares in electronic form or physical form are, therefore, requested to submit the PAN or Bank Details as the case may be to their Depository Participant(s) with whom they are maintaining their demat accounts and members holding shares in physical form to the Company /its RTA.
- 29. The Register of Directors' and Key Managerial Personnel and their shareholding maintained under Section 170 of the Companies Act, 2013, the Register of contracts or arrangements in which the Directors are interested under Section 189 of the Companies Act, 2013 and all other documents referred to in the Notice will be available for inspection at the Registered Office of the Company during normal business hours (10:00 a.m. to 06:00 p.m.) on all working days except Friday and public holidays up to the date of the 39th AGM of the Company.
- 30. The details of the Director seeking re-appointment at the AGM, pursuant to the provisions of Regulation 36(3) of the SEBI Listing Regulations, para 1.2.5 of the Secretarial Standards on General Meetings (SS-2) and other applicable provisions are provided in Annexure to this Notice and forming part of the Explanatory Statement.
- 31. In order to use natural resources, we request members to update their Email ID with their depository Participants to enable the Company to send communications electronically.
- 32. Members who hold shares in physical form in multiple folios in identical names or joint holding in same order of names, if any, are requested to send the share certificates to Link Intime India Private Limited, for consolidation into a single folio.
- 33. Members desirous of obtaining any information concerning the accounts or operations of the Company are requested to communicate their questions in writing to the Company, on info@creative-cast.com, at least 10 (Ten) days before the date of the Meeting so that the information required may be made available at the Meeting.
- 34. The Company has designated an exclusive E-mail ID: info@creative-cast.com for redressal of Shareholders' / Investors' complaints / grievance. In case you have any queries, complaints or grievances, then please write to us at the above mentioned E-mail ID.
- 35. Members may kindly note that in accordance with SEBI Master Circular for Online Resolution of Disputes in the Indian Securities Market bearing no. 

Operational performance: -

The Company continues to specialize in the manufacturing of investment casting products and has expanded its revenue streams through windmill turbines. With a robust production capacity, the Company now supplies over 5000 different types of castings in both as-cast and fully machined conditions. These products cater to a wide range of engineering applications, including pumps and valves, defense, oil and refinery, fire control equipment, and automobiles, among others.

Financial performance:

The financial year 2023-24 marked a steady performance for the Company, with revenue reaching Rs. 5,316.99 lakh, reflecting a modest increase from the previous year. The Gross Profit before Finance Cost, Depreciation, and Taxation (PBIDT) was Rs. 719.11 lakh, maintaining stability compared to the prior year. The Company successfully managed its finance costs, which remained minimal at Rs. 2.51 lakh. Profit Before Tax (PBT) saw a slight improvement to Rs. 653.28 lakh, and after accounting for taxes, the Profit After Tax (PAT) rose to Rs. 506.66 lakh, up from Rs. 478.79 lakh in the previous year. These figures highlight the Company's resilience and effective cost management, leading to sustained profitability.

This strong financial and operational performance underscores the Company's commitment to maintaining a competitive edge in the market and delivering consistent value to its stakeholders. The Board remains optimistic about the future prospects of the Company and will continue to explore new opportunities for growth and innovation.

No material changes or commitments have transpired between the end of the financial year and the date of this report that would impact the Company's financial standing.

The Audited Standalone Financial Statements of the Company, along with all necessary attachments, have been part of the Annual Report for the year 2023-24. This complete report is accessible on the Company's official website at www.creative-cast.com.

Dividend:

The Board of Directors is delighted to propose a final dividend of Rs. 10 per equity share having a face value of Rs. 10 each (i.e., @ 100%) for the financial year 2023-24. This dividend will be paid to the members whose names are appear in the Register of Members as of the Record Date, subject to approval by the members at the ensuing 39th Annual General Meeting.

The proposed Dividend, if approved during the 39th Annual General Meeting of the Company, will not be subjected to dividend distribution tax, as it has been eliminated. However, it will be subject to Tax Deducted at Source (TDS) in accordance with the applicable rates, as specified in the notice for the 39th AGM.

Transfer to Reserve:

The Company's Board of Directors has decided not to transfer any funds to the Reserves for the financial year being reviewed.

Share Capital:

There were no changes carried out in the capital structure of the Company during the year under review.

Investor Education and Protection Fund (IEPF): -

The Company's Board of Directors affirms that there are no pending amounts to be transferred to the Investor Education and Protection Fund for the year under consideration.

Meetings of the Board:

Throughout the year, the Board of Directors met regularly to review the Company's performance, discuss various business strategies, and address important issues. Accordingly, at the 38th Annual General Meeting held on September 23, 2023, the Company passed a special resolution approving the continuation of directorship for Mr. Dhirubhai Haribhai Dand (DIN: 00284065) and Mr. Ramniklal Savjibhai Tilva (DIN: 08193261), who will reach the age of 75 years on June 1, 2024, and May 6, 2024, respectively.

(iii) Cessations:

There were no instances of cessation of Directors or Key Managerial Personnel (KMPs) during the period under review.

(iv) Retire by Rotation:

In accordance with the provisions of Section 152 of the Companies Act, 2013, and the Company's Articles of Association, Mr. Dhirubhai Haribhai Dand (DIN: 00284065), Director, is liable to retire by rotation at the forthcoming 39th Annual General Meeting. Being eligible, he has offered himself for reappointment, and the Board has recommended his reappointment as a Director of the Company.

Declaration by Independent Directors:

The Company has received declarations / confirmations from all the Independent Directors of the Company as required under Section 149(7) of the Act read with Rule 6 of the Companies (Appointment and Qualifications of Directors) Rules, 2014 and Regulation 25(8) of the SEBI Listing Regulations. Furthermore, the Independent Directors have adhered to the Code of Independent Directors as stipulated in Schedule IV of the Act.

Formal annual evaluation and its criteria: _

Pursuant to the provisions of the Act, SEBI Listing Regulations and Nomination and Remuneration Policy of the Company, the Nomination and Remuneration Committee ("NRC") and the Board has carried out the annual performance evaluation of the Board, its Committees and individual Directors by way of individual and collective feedback from Directors. The Independent Directors have also carried out annual performance evaluation of the Chairperson, the non-independent directors and the Board as a whole. Structured questionnaires covering the evaluation criteria laid down by the NRC, prepared after taking into consideration inputs received from Directors, were used for carrying out the evaluation process. Furthermore, details of the investments made by the Company are provided in Notes No. 6 and 10 of the Financial Statements, which are self-explanatory.

During the financial year, all contracts, arrangements, or transactions executed by the Company with related parties were conducted in the ordinary course of business and on an arm's length basis. MANAGEMENT DISCUSSION AND ANALYSIS REPORT

I An Overview:

The Management's Discussion and Analysis ("MD&A") summarizes the financials and relays management's insights into the company's performance. This Management Discussion and Analysis Report of Creative Castings Limited, for the year ended on March 31, 2024 contains financial highlights but does not contain the complete financial statements of the Company. This should be read in conjunction with the Company's audited financial statements, the schedules and notes thereto and the other information included elsewhere in the Annual Report. Statements in the Management Discussion and Analysis Report describing the Company's objectives, projections, estimates and expectations may be forward looking statements within the meaning of applicable securities laws and regulations. Actual results might differ materially from those expressed or implied. MD&A is headed towards providing a narrative explanation of a company's financial statements that enables investors to see the company through the eyes of management and to enhance financial disclosure.

II. About the Company:

Creative Castings Limited, established in 1980, is India's most trusted and quality-focused investment casting manufacturer and exporter, specializing in the lost wax process. With an installed capacity of 840 MT per annum, the Company is dedicated to delivering precision parts with assured material and casting quality. We are equipped with state-of-the-art facilities and expertise to uphold this commitment. The Company's office and plant span an area of 8,924 square meters, with a production area of approximately 3,500 square meters. Our facilities are outfitted with the latest technology in production, testing, and measurement, and we have a full standby captive power generation system to ensure uninterrupted production. Additionally, during the year under review, the Company acquired a GIDC-owned leasehold land measuring 5,285.14 square meters, located at Plot No. 320, GIDC-II, Dolatpara, Junagadh.

The Company is engaged in supply over 5,628 different types of castings in as cast & in fully machined conditions to almost every field of engineering applications such as pumps & valves, defense, oil & refinery, fire control equipment, automobiles etc.

An experience of more than three decades in design & manufacture of complicated parts weighing from few grams to 120 kg, the Company can handle large volumes 100000 pieces /month ability to handle over more than 250 different alloys to customized specification.

Company has strong business relationship since more than 30 years with its 50% world largest customers.

III. Financial Performance:

The financial performance of the company for the fiscal year 2023-2024 shows a steady and modest improvement compared to the previous year. The total income for the year increased to Rs. 5,316.99 lakhs, up by Rs. 38.94 lakhs from Rs. 5,278.05 lakhs in 2022-2023. This represents a slight growth of approximately 0.74%, indicating that the company's revenue streams remained stable with a marginal increase. On the expense side, the total expenses also saw a small rise, moving from Rs. 4,630.64 lakhs in 2022-2023 to Rs. 4,663.71 lakhs in 2023-2024, an increase of Rs. 33.07 lakhs. This increase in expenses is lower than the increase in income, which has positively impacted the profitability of the company.

The profit before tax (PBT) for the year stood at Rs. 653.28 lakhs, slightly higher than the Rs. 647.41 lakhs recorded in the previous year, demonstrating the company's ability to manage its expenses effectively and maintain its profit margins. However, tax expenses decreased from Rs. 168.62 lakhs in 2022-2023 to Rs. 146.62 lakhs in 2023-2024. This reduction in tax liability further enhanced the profit after tax (PAT), which increased to Rs. 506.66 lakhs from Rs. 478.79 lakhs, reflecting a growth of Rs. 27.87 lakhs or about 5.82%. Overall, the company has shown consistent financial performance with an improvement in profitability, driven by controlled expenses and reduced tax burdens.

As we progress, our company remains dedicated to continuous improvement in performance and the implementation of effective and efficient management strategies to propel us toward our financial objectives.

Your Company has prepared its financial statements in accordance with Indian Accounting Standards ("Ind AS") as per the Companies (Indian Accounting Standard) Rules, 2015 as amended and notified under section 133 of the companies act 2013 (the "Act") and other relevant provisions of the Act. These financial statements have been prepared and presented on the accrual basis of accounting under historical cost convention or fair values as per the requirement of Ind AS prescribed under section 133 of the Act. The financial statements prepared as per the applicable Accounting Standards and there is no any material departure or deviation in giving treatment to any transactions hence management discussion thereon is unsolicited.

IV. History:

The company was incorporated as "Creative Castings Private Limited" on November 22, 1985. After Incorporation, the said company took over the running business of the erstwhile Partnership firm, M/s. Creative Castings with effect from March 21, 1986 on dissolution of the Partnership firm. All the assets and liabilities were transferred to Creative Castings Private Limited. The business set up by the firm in 1980 was carried by the company and all the erstwhile partners of the firm were appointed as the directors on the board of the company. The Company became a Public Limited Company on October 06, 1994.

V. Product Line: -

Creative Castings Ltd. is a manufacturer & exporter of machined as well as unmachined investment castings to all key user industries like Pumps & Valve Industries, Oil & Refineries, General Engineering, Electrical engineering, Fire control equipments, Medical implants, Agricultural Machineries, Defense Industries etc.

The company has two furnaces with capacities of 300 kg each per heat. The company's product has wide range of application in different industries viz. Industrial Pumps, Electrical Engg., Valve Industries, Anti Fire Equipment, Defense Industries, Instrumentations, Medical Implants, General Engineering, Oil and Gas Industries, Power Industries etc. The Company has developed over 5,628 various types of castings till date.

Moreover, the castings produced by the company find applications in automobiles, chemical processing, food processing, pharmaceutical, fertilizer industry and engineering products.

The Company manufactures both ferrous and non-ferrous castings. Ferrous castings comprise of Stainless Steel castings of various grades and Carbon steel, which accounts for around 60% and 30% respectively of the production. Non-ferrous castings consist of Cobalt base alloy and Nickel base alloy castings, which accounts for around 10% of the production.

VI. Segment-wise or product-wise performance: ,

VII. Global and Indian Economy: An Overview and Outlook

Global Economy:

The global economy remained resilient in 2023 despite tightening financial conditions and geopolitical tensions. Global GDP grew by 3.2%, supported by the US and emerging markets. Inflation eased to 6.8% from 8.7% in 2022 due to monetary tightening and improved supply chains. Global trade volume contracted by 1.2% as demand shifted from goods to services, and financial markets saw volatility driven by fluctuating perceptions of monetary policy.

The global economy faces uncertainties, with growth expected to moderate due to persistent geopolitical risks and financial market volatility. Inflation may remain a concern in some regions, though central banks' efforts could keep it in check.

Indian Economy:

The Indian economy demonstrated resilience with a real GDP growth of 7.6%, driven by strong fixed investment. Manufacturing and services sectors performed well, while agriculture faced a slowdown. Inflation moderated, falling within the tolerance band due to anti-inflationary measures. Fiscal consolidation continued, focusing on capital expenditure. Financial markets remained stable, with robust equity market gains and a stable INR. Improvements in the external sector and reduced current account deficit supported foreign exchange reserves.

India's economy is poised to sustain its growth momentum, driven by infrastructure investments and a robust services sector. However, challenges such as global economic conditions and domestic inflationary pressures will need careful monitoring.

VIII. Industry's structure and outlook: .

Global Scenario:

Globally, the foundry market experienced steady demand, particularly driven by key sectors such as automotive, aerospace, construction, and energy. The automotive industry remained a significant contributor, leveraging advanced casting

technologies to produce lightweight, high-efficiency components. The aerospace sector, with its focus on precision and strength, also fueled demand for specialized castings.

Asia-Pacific, especially China and India, dominated the global foundry market, accounting for approximately 45% of the market share. This region benefited from rapid industrialization, urbanization, and government initiatives supporting technological advancements in casting processes. The competitive labor costs and significant investments in advanced technologies further solidified the region's leadership in the global market.

In North America and Europe, the foundry market, though more mature, saw investments in high-value precision castings. These regions focused on adopting innovative technologies to meet the sophisticated demands of industries like automotive and aerospace. The U.S., for instance, witnessed strong casting sales driven by infrastructure projects, despite economic challenges.

Domestic Scenario:

India maintained its position as the second-largest producer of castings globally, with production increasing to approximately 14.16 million metric tonnes in 2022-23. The Indian foundry industry, with around 4,500 units - primarily MSMEs - generated significant employment, employing about 2 million people directly and indirectly. The industry's revenue was estimated at USD 20 billion, with exports contributing USD 3.94 billion.

The growth of the Indian foundry industry was bolstered by government initiatives like "Make in India" which encouraged infrastructure development and eased foreign direct investment (FDI) norms. Key sectors driving this growth included automotive, railways, and construction equipment. Additionally, the push towards modernization, adoption of environmental friendly technologies, and an expanding export market opened new avenues for growth.

Overall, the casting and foundry industry showed a promising outlook for FY 2023-24, with strong sectoral demands and strategic investments in technology and infrastructure, ensuring continued growth despite global economic headwinds.

IX. Opportunities & Threats: .

Opportunities:

Growing Demand in Key Sectors.

- Automotive Sector: The push towards electric vehicles (EVs) and lightweight, fuel-efficient vehicles is driving
 demand for advanced casting technologies. The need for complex, lightweight components presents a significant
 growth opportunity.
- Infrastructure and Construction: Ongoing global infrastructure projects, especially in developing regions, require
 durable cast parts for machinery and structural components, creating substantial demand.
- Aerospace and Defense: The increasing demand for high-precision components in aerospace and defense sectors, particularly in countries like the U.S. and India, provides opportunities for growth in investment and die casting.
- Technological Advancements: The adoption of Industry 4.0 technologies, such as automation, robotics, and 3D printing, offers opportunities to enhance efficiency, reduce waste, and produce more complex castings.

Expanding Export Markets.

 The Indian foundry industry has seen a surge in exports, with markets expanding into Europe, North America, and the Middle East. Government initiatives promoting exports and easing FDI norms further enhance these opportunities.

Environmental Regulations and Green Casting

 There is a growing demand for environmentally sustainable practices in foundries. Foundries that adopt greener technologies and materials, such as the use of renewable energy or the reduction of carbon footprints, are likely to gain a competitive edge.

Threats:

Economic Uncertainty and Recession Risks.

- Global Recession Risks: Economic downturns, particularly in mature markets like North America and Europe, can lead to reduced industrial activity, impacting the demand for castings. Recession fears have led to cautious spending, with some foundries expecting a slowdown in orders.
- Material Cost Volatility: Fluctuations in the cost of raw materials, such as metals and energy, pose significant challenges to maintaining profitability. Supply chain disruptions can exacerbate this threat.

Technological Disruption:

 The rapid pace of technological advancements can be both an opportunity and a threat. Foundries that fail to adopt new technologies risk falling behind their competitors, especially as automation and precision casting become industry standards.

Environmental and Regulatory Pressures:

- Stringent environmental regulations, especially in regions like Europe and North America, require foundries to invest
 heavily in cleaner technologies and processes. Failure to comply can result in heavy fines and loss of market access.
- Energy Consumption: Foundries are energy-intensive, and rising energy costs or stringent regulations on energy use could impact the profitability of operations, particularly in energy-dependent processes like melting and molding.

Labor Shortages:

 The foundry industry is labor-intensive, and a shortage of skilled workers, exacerbated by an aging workforce and limited new entrants, poses a significant threat to maintaining production levels and quality.

In summary, while the casting and foundry industry is poised for growth due to demand from key sectors and technological advancements, it faces substantial risks from economic uncertainties, regulatory pressures, and the need for continuous technological adaptation.

X. Risks and areas of concern:

The Company is working on enhancing its competencies to take care of current and future business. Its employee strength as on March 31, 2024 was 125 (P.Y. it was 134). Human Resource and Industrial Relations departments have developed systems and policies on recruitment, performance management, learning and development, and employee engagement.

The high level of motivation of the employees and their identification with the company is the basis for the creation of a strong team who continuously advance the innovative brands and superior technologies with their inventive talent and pioneering spirit. The training courses are evolved to internalize the principles of sustainable development and to uphold the Company's corporate culture based on fairness and team spirit.

Internal control systems and adequacy:

Internal controls are designed to provide reasonable assurance regarding the reliability of financial reporting and the preparation of financial statements for external purposes in accordance with IFRS. Absolute assurance cannot be provided that all misstatements have been detected because of inherent limitations in all control systems.

The Company's internal control policies are in line with its size and nature of operations and they provide assurance that all assets are safeguarded, transactions are authorised, recorded and reported properly following all applicable statutes, General Accepted Accounting Principles, company's Code of Conduct and corporate policies. The Company has an Audit Committee, which conducts audit in various functional areas as per audit plan approved by the Audit Committee. The audit committee has a good understanding of the organization's framework and related components of internal control. The Company has appointed an Internal Auditor who, from time to time, draw attention of chairman of Audit Committee of the Company about the gray area needs improvements. Audit planning and executions are oriented towards assessing the state of internal controls, making them stronger and addressing the risks in the functional areas of the Company and suggests improvements for strengthening them. Similarly, the Internal Auditors are also responsible for monitoring the Internal Control Systems.

REPORT ON CORPORATE GOVERNANCE

Company's Philosophy on Corporate Governance:

I. Board of Directors:

- a. The Board's constitution is in conformity with Regulation 17 and 17A of the SEBI Listing Regulations, as well as the provisions outlined in the Companies Act, 2013 (referred to as "the Act"), subject to amendments over time. As of March 31, 2024, the Board of the Company consists of 10 (ten) Directors. Among these, 2 (Two) Directors are categorized as executive directors, representing the promoters' group. Additionally, there are 5 (Five) Independent Directors, including a woman director, and the remaining 3 (three) Directors are designated as non-executive directors, also affiliated with the promoters' group.
- b. The Board has an optimum combination of Executive and Non-Executive Directors with the Chairman being Non-Executive Director belonging to promoter group and not less than fifty percent of the Board comprising Independent Directors including one Woman Independent Director. The Board reviews and approves strategy and oversees performance of the Management to ensure that the long-term objectives of enhancing Stakeholders' value are achieved.
- c. The Management of the Company is entrusted in the hands of skilled Key Managerial Personnel(s), headed by Mr. Rajan R. Bambhania, Managing Director of the Company. Alongside Managing Director, Mr. Siddharth V. Vaishnav is sharing his expertise with the Company as a Whole Time Director. Mrs. Ruta A. Gardi is a woman Independent Director in the Board of Directors strengthening gender equality.
- d. The Independent Directors are experienced from diverse fields, possess qualifications which enable them to discharge their responsibilities, provide effective leadership to business and enhance the quality of Board's decision-making process.
- e. The maximum tenure of Independent Directors is in compliance with the Companies Act, 2013 ("the Act") and the SEBI Listing Regulations. All the Independent Directors have confirmed that they meet the criteria as mentioned in Regulation 16(1)(b) of the SEBI Listing Regulations and Section 149(6) of the Act. The Independent Directors have also confirmed that they are not aware of any circumstance or situation, which exist or may be reasonably anticipated, that could impair or impact their ability to discharge their duties with an objective independent judgment and without any external influence. 

How our audit addressed the key audit matter

We performed the following audit procedures, amongst others:

- Obtained an understanding of the Company's sales process, including design and implementation of controls over timing of recognition of revenue from sale of goods and tested the operating effectiveness of these controls.
- Reviewed the Company's accounting policies for revenue recognition in context of the applicable accounting standard.
- Obtained customer contracts on sample basis and read the terms to assess various performance obligations in the contract, the point in time of transfer of control and pricing terms.
- Tested on sample basis sales invoices for

the point of acceptance of goods by customer. Further, the pricing of the products is dependent on metal indices and foreign exchange fluctuation making the price volatile.

Due to judgments relating to determination of point in time in satisfaction of performance obligations with respect to sale of products, this matter has been considered as key audit matter. and terms of contract with customers. Further, we performed procedures to test on a sample basis whether revenue was recognized in the appropriate period by testing shipping records, good inwards receipt of customer, sales invoice, Inco-terms etc. and testing the management assessment involved in the process, wherever applicable.

MATERIAL ACCOUNTING POLICIES INFORMATION AND NOTES FORMING PART OF THE FINANCIAL STATEMENTS FOR THE FINANCIAL YEAR ENDED ON 31ST MARCH, 2024.

1.0 GENERAL INFORMATION ..

- 1.1 M/s. Creative Castings Limited (the "Company") is a public limited company domiciled in India. The Company is engaged in manufacturing and selling of all types of Steel and Alloy Steel Investment Castings. The company is also engaged in generating of power from wind energy. The Casting Manufacturing unit of the Company is situated at G.I.D.C. Estate, Phase II, Rajkot Road, Dolatpara, Junagadh 362003. The company caters to both domestic and international markets. The Company's shares are listed with BSE.
- 1.2 The functional currency of the Company is Indian Rupee ("\(\tau\).") and presented in the nearest of Lakhs of rupees unless stated to be otherwise, which is the currency of primary economic environment in which the Company operates.

2.0 MATERIAL ACCOUNTING POLICIES INFORMATION _

2.1 STATEMENT OF COMPLIANCE _

- (a) These financial statements have been prepared in accordance with Indian Accounting Standards ("Ind AS") as per the Companies (Indian accounting standard) Rules, 2015 as amended and notified under section 133 of the companies act 2013 (the "Act") and other relevant provisions of the Act.
- (b) The aforesaid financial statements have been approved by the Board of Directors in the meeting held on May 25, 2024.

2.2 BASIS OF PREPARATION AND PRESENTATION ..

- (a) These financial statements have been prepared and presented on the accrual basis of accounting under historical cost convention or fair values as per the requirement of Ind AS prescribed under section 133 of the Act read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time.
- (b) Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.
- (c) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique in estimating the fair value of an asset or a liability, the Company takes in to account the Characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date.
- (d) Fair value for measurement and/or disclosure purposes in these financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of Ind AS 102, leasing transactions that are within the scope of Ind AS 116, and measurements that have some similarities to fair value but are not fair value, such as net realizable value, in Ind AS 2 or value in use in Ind AS 36.
- (e) In addition, for financial reporting purposes, fair value measurements are categorized into level 1, 2, or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurements in its entirety, which are described as follows.
 - Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity
 can access at the measurement date.
 - Level 2 inputs are inputs, other than quoted prices included within level 1 that are observable for the asset or liability, either directly or indirectly.
 - Level 3 inputs are unobservable inputs for the asset or liability.
- (f) All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle or 12 months or other criteria as set out in the Schedule III to the Companies Act 2013. Based on the nature of its business, the Company has ascertained its operating cycle to be 12 months for the purpose of current and non-current classification of assets and liabilities.

2.3 REVENUE RECOGNITION .

- (a) Revenue is recognized to the extent that it is probable that the economic benefits will flow to the company and the revenue can be reliably measured.
- (b) Revenue towards satisfaction of a performance obligation is measured at the amount of transactions price (net of variable consideration) allocated to that performance obligation. The transaction price of goods and services rendered is net of variable consideration on account of various discounts, rebate, returns etc.
- (c) The following specific recognition criteria must also be met before revenue is recognized.

Sales of goods

Revenue from sale of goods is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the equipment. The normal credit term is 30 to 90 days upon delivery.

The Company considers whether there are other promises in the contract that are separate performance obligations to which a portion of the transaction price needs to be allocated (e.g., warranties, customer loyalty points). In determining the transaction price for the sale of equipment, the Company considers the effects of variable consideration, the existence of significant financing components, noncash consideration, and consideration payable to the customer (if any).

(i) Variable consideration

If the consideration in a contract includes a variable amount, the Group estimates the amount of consideration to which it will be entitled in exchange for transferring the goods to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved. Some contracts for the sale of electronic equipment provide customers with a right of return the goods within a specified period. The Group also provides retrospective volume rebates to certain customers once the quantity of electronic equipment purchased during the period exceeds the threshold specified in the contract. The rights of return and volume rebates give rise to variable consideration.

Rights of return

The Group uses the expected value method to estimate the variable consideration given the large number of contracts that have similar characteristics. The Group then applies the requirements on constraining estimates of variable consideration in order to determine the amount of variable consideration that can be included in the transaction price. A refund liability is recognized for the goods that are expected to be returned (i.e., the amount not included in the transaction price). A right of return asset (and corresponding adjustment to cost of sales) is also recognised for the right to recover the goods from a customer.

· Volume rebates

The Group applies the most likely amount method or the expected value method to estimate the variable consideration in the contract. The selected method that best predicts the amount of variable consideration is primarily driven by the number of volume thresholds contained in the contract. The most likely amount is used for those contracts with a single volume threshold, while the expected value method is used for those with more than one volume threshold. The Group then applies the requirements on constraining estimates in order to determine the amount of variable consideration that can be included in the transaction price and recognised as revenue. A refund liability is recognised for the expected future rebates (i.e., the amount not included in the transaction price).

Interest

Interest income is recognized on a time proportion basis taking into account the amount outstanding and the applicable interest rate. Interest income is included under the head "other income" in the statement of profit and loss.

Dividend Income

Dividend income is recognized when the company's right to receive dividend is established by the reporting date.

Windmill energy income

Consideration for electricity generated by the windmill division and fed into the state power grid is received in the form of credit in the manufacturing division's power bill. Credits are recognised as income net of wheeling charges. Income so recognised is shown separately from the power cost under other operating revenue.

Other income is recognized on accrual basis provided that it is probable that the economic benefits will flow to the company and the amount of income can be measured reliably.

2.4 PROPERTY, PLANT AND EQUIPMENT _

The cost of property, plant and equipment comprises its purchase price, any import duties and other taxes (other than those subsequently recoverable from the tax authorities), any directly attributable expenditure on making the asset ready for its intended use, including relevant borrowing costs for qualifying assets and any expected costs of decommissioning, net of any trade discounts and rebates. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance, are charged to the Statement of profit and loss in the period in which the costs are incurred unless such expenditure results in a significant increase in the future benefits of the concerned asset.

An item of property, plant and equipment is derecognized upon disposal or on retirement, when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the net sale proceeds and the carrying amount of the asset and is recognized in statement of profit and loss.

Property, plant and equipment are stated in the balance sheet at cost less accumulated depreciation and accumulated impairment losses, if any.

The company has elected to continue with the carrying value for all of its property, plant and equipment as recognized in the financial statements as at the date of transition to Ind AS i.e. 1 April-2016, measured as per the previous GAAP and use that as its deemed cost as at the date of transition.

Depreciation commences when the assets are ready for their intended use. Depreciable amount for assets is the cost of an asset, or other amount substituted for cost, less its estimated residual value. Depreciation is recognized so as to write off the cost of assets (other than properties under construction) less their residual values over their useful lives, using straight-line method as per the useful life prescribed in schedule II to the companies Act, 2013. In respect of additions to property, plant and equipment, depreciation has been charged on pro rata basis.

The company reviews the residual value, useful lives and depreciation method annually and, if current estimates differ from previous estimates, the change is accounted for as a change in accounting estimate on a prospective basis.

2.5 CAPITAL WORK IN PROGRESS —

(a) Asset during construction is capitalized in the assets under capital work in progress account. At the point when an asset is operating at management's intended use, the cost of construction is transferred to the appropriate category of property, plant and equipment and depreciation on that asset will be commenced.

2.6 INTANGIBLE ASSETS

- (a) Intangible assets with finite useful lives that are acquired separately are carried at cost less accumulated amortization and accumulated impairment losses. Amortization is recognized on a Straight-line basis over their estimated useful lives. The estimated useful life and amortization method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis. Intangible assets with indefinite useful lives that are acquired separately are carried at cost less accumulated impairment losses.
- (b) An item of intangible assets is derecognized upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on Derecognition of the asset is included in the statement of profit or loss when the asset is derecognized.
- (c) Intangible Assets amortized as follows:
 - Computer Software is amortized over the useful life estimated by the management over a period of 5 years.

2.7 IMPAIRMENT OF PROPERTY, PLANT AND EQUIPMENT AND INTANGIBLE ASSETS -

- (a) At the end of each reporting period, the company reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). Where it is not possible to estimate the recoverable amount of individual assets, the Company estimates the recoverable amount of the cash-generating unit to which the asset belongs. Where a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.
- (b) Intangible assets with indefinite useful lives and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that the asset may be impaired.
- (c) Recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.
- (d) If the recoverable amount of an asset (or cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash- generating unit) is reduced to its recoverable amount. An impairment loss is recognized immediately in the statement of Profit and Loss, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.

(e) Any reversal of the previously recognized impairment loss is limited to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined if no impairment loss had previously been recognized.

2.8 LEASES .

The company assesses at contract inception whether a contract is, or contains, a lease. That is, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Where the company is lessee

Company's leased assets comprise of lands. The company applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low- value assets. The company recognises lease liabilities to make lease payments and right- of-use assets representing the right to use the underlying assets.

Right_of_use assets

The company recognises right-of-use assets at the commencement date of the lease (i.e., the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognized, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the lease term and the estimated useful lives of the assets, the right-of-use assets are also subject to impairment. Refer to the accounting policies in section F Impairment of property, plant and equipment and intangible assets.

Lease liabilities

At the commencement date of the lease, the company recognises lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the company and payments of penalties for terminating the lease, if the lease term reflects the company exercising the option to terminate. Variable lease payments that do not depend on an index or a rate are recognised as expenses (unless they are incurred to produce inventories) in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the company uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in the lease payments (e.g., changes to future payments resulting from a change in an index or rate used to determine such lease payments) or a change in the assessment of an option to purchase the underlying asset.

Short-term leases and leases of low-value assets

The Company applies the short-term lease recognition exemption to its short-term leases (i.e., those leases that have a lease term of 12 months or less from the commencement date with no option for extension and do not contain a purchase option). It also applies the lease of low-value assets recognition exemption to leases that are considered to be low value. Lease payments on short-term leases and leases of low-value assets are recognised as expense on a straight-line basis over the lease term.

Company as Lessor

Leases in which the company does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. Rental income arising is accounted for on a straight-line basis over the lease terms and is included in other income in the statement of profit or loss. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income.

2.9 INVENTORIES.

- (a) Inventories are stated at lower of cost and net realizable value. Cost comprises of purchase price, applicable taxes, less rebates, discounts and conversion costs and other costs incurred in bringing the inventories in to their present location and condition. Net realizable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.
- (b) Stores and spares which do not meet the definition of property, plant and equipment are accounted as inventories.
- (c) Inventories are valued at

2.10 EMPLOYEE BENEFITS

- (a) In respect of defined contribution plan the company makes the stipulated contributions to provident fund and pension fund, in respect of employees to the respective authorities under which the liability of the company is limited to the extent of the contribution.
- (b) The liability for gratuity, considered as defined benefit, is determined actuarially using the projected unit credit method, with actuarial valuations being carried out at the end of each annual reporting period. Re-measurement, comprising actuarial gains and losses, the effect of the changes to the asset ceiling (if applicable) and the return on plan assets (excluding interest), is reflected immediately in the statement of financial position with a charge or credit recognized in other comprehensive income in the period in which they occur. Re-measurement recognized in other comprehensive income is reflected immediately in retained earnings and will not be reclassified to profit or loss. Past service cost is recognized in period of a plan amendment. Net interest is calculated by applying the discount rate at the beginning of the period to the net defined benefit liability or asset. Defined benefit costs are categorized as follows:
 - Service cost (including current service cost, past service cost, as well as gains and losses on curtailments and settlements);
 - · Net interest expense or income; and
 - Re-measurement,
- (c) The Company presents the first two components of defined benefit costs in profit or loss in the line item 'Employee benefits expenses'. Curtailment gains and losses are accounted for as past service costs.
- (d) The retirement benefit obligation recognized in the statement of financial position represents the actual deficit or surplus in the Company's defined benefit plans. Any surplus resulting from this calculation is limited to the present value of any economic benefits available in the form of refunds from the plans or reductions in future contributions to the plans.
- (e) A liability for a termination benefit is recognized at the earlier of when the entity can no longer withdraw the offer of the termination benefit and when the entity recognizes any related restructuring costs.
- (f) A liability is recognized for benefits accruing to employees in respect of wages and salaries, annual leave and sick leave in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service. Liabilities recognized in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in exchange for the related service.

2.11 TAXATION

(a) Income tax expense represents the sum of the tax currently payable and deferred tax.

Current Tax

(b) Current Tax is the amount of tax payable based on the taxable profit for the year as determined in accordance with the applicable tax rates and the provisions of the India Income Tax Act, 1961.

Deferred Tax

- (c) Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognized for all taxable temporary differences. Deferred tax assets are generally recognized for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilized. Such deferred tax assets and liabilities are not recognized if the temporary difference arises from the initial recognition of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.
- (d) The carrying amount of deferred tax assets is reviewed at the end of each annual reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.
- (e) Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realized, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.
- (f) Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority.

- (g) Current and deferred tax are recognized in the statement of profit and loss, except when they are related to item that are recognized in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognized in other comprehensive income or directly in equity respectively.
- (h) Minimum Alternate tax (MAT) paid in accordance with the tax laws, which gives future economic benefits in the form of adjustment to future income tax liability, is considered as an asset if there is convincing evidence that the company will pay normal income tax. Accordingly, MAT is recognized as an asset in the Balance Sheet when it is highly probable that future economic benefit associated with it will flow to the Company.

2.12 FOREIGN CURRENCIES

- (a) The functional currency of the Company is determined based on the primary economic environment in which it operates. The functional currency of the Company is Indian National Rupee (INR).
- (b) The transactions in currencies other than the entity's functional currency (foreign currencies) are recognized at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.
- (c) Exchange differences on monetary items are recognized in statement of Profit and Loss in the period in which they arise except for;
- Exchange differences on foreign currency borrowings relating to assets under construction for future productive
 use, which are included in the cost of those assets when they are regarded as an adjustment to interest costs on those
 foreign currency borrowings;
- Exchange differences on monetary items receivable from or payable to a foreign operation for which settlement is
 neither planned nor likely to occur (therefore forming part of the net investment in the foreign operation), which are
 recognized initially in other comprehensive income and reclassified from equity to statement of Profit and Loss on
 repayment of the monetary items.

2.13 PROVISIONS, CONTINGENT LIABILITIES AND CONTINGENT ASSETS

- (a) Provisions are recognized when the Company has a present obligation (legal or constructive), as a result of past events, and it is probable that an outflow of resources, that can be reliably estimated, will be required to settle such an obligation.
- (b) The amount recognized as a provision is the best estimate of the consideration required to settle the present obligation at the balance sheet date, considering the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material).
- (c) When some or all the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognized as an asset if it is virtually certain that the reimbursement will be received and the amount of the receivable can be measured reliably.
- (d) Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or a reliable estimate of the amount cannot be made. Contingent liabilities and contingent assets are not recognized but are disclosed in the notes.

2.14 EARNING PER SHARE

- (a) Basic earnings per share is computed by dividing the profit / (loss) after tax attributable to equity shareholders by the weighted average number of equity shares outstanding during the year. The weighted average number of equity shares outstanding during the year is adjusted for bonus issue, bonus element in a rights issue to existing shareholders, share split and reverse share split (consolidation of shares).
- (b) Diluted earnings per share is computed by dividing the profit / (loss) after tax attributable to equity shareholders as adjusted for dividend, interest and other charges to expense or income (net of any attributable taxes) relating to the dilutive potential equity shares, by the weighted average number of equity shares considered for driving basis earnings per share and the weighted average number of equity shares which could have been issued on the conversion of all dilutive potential equity shares.

2.15 BORROWING COSTS

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use. All other borrowing costs are recognized in the Statement of Profit and Loss in the period in which they are incurred.

2.16 GOVERNMENT GRANTS AND SUBSIDIES .

- (a) Government grants are recognized by the company where there is reasonable assurance that the grants will be received and all the attached conditions will be complied with. Revenue grants are recognized in the Statement of Profit and Loss in the same period, in which the related costs are incurred are accounted for.
- (b) Government grants relating to Property, plant and equipment are recognized / presented as deferred income and released to the statement of Profit and Loss over the expected useful lives of the assets concerned.

2.17 FINANCIAL INSTRUMENTS.

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through statement of profit and loss ('FVTPL')) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit and loss are recognized immediately in Statement of Profit and Loss.

[A] Financial Assets

Initial recognition and measurement.

(a) All financial assets are recognized initially at fair value. Transaction costs that are directly attributable to the acquisition of financial assets (other than financial assets at fair value through statement of profit and loss ('FVTPL') are added to the fair value of the financial assets, on initial recognition. Transaction cost directly attributable to the acquisition of financial assets at FVTPL is recognized immediately in Statement of Profit and Loss. However, trade receivables that do not contain significant financial component are measured at transaction costs.

Subsequent measurement

- (b) For purposes of subsequent measurement, financial assets are classified in four categories:
 - · Debt instruments at amortized cost;
 - Debt instruments at fair value through other comprehensive income (FVTOCI);
 - Debt instruments and equity instruments at fair value through profit or loss (FVTPL);
 - Equity instruments measured at fair value through other comprehensive income (FVTOCI).

Debt instruments at amortized cost:

- (c) A 'debt instrument' is measured at the amortized cost if both the following conditions are met:
 - The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding, and
 - The asset is held within a business model whose objective is to hold assets for collecting contractual cash flows.
- (d) After initial measurement, such financial assets are subsequently measured at amortized cost using the effective interest rate (EIR) method. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortization is included in finance income in the profit or loss. The losses arising from impairment are recognized in the profit or loss. This category generally applies to trade and other receivables.

Debt instrument at FVTOCI:

- (e) A 'debt instrument' is classified as FVTOCI if both of the following criteria are met:
 - The objective of the business model is achieved both by collecting contractual cash flows and selling the financial
 assets, and
 - The asset's contractual cash flow represents SPPI.
- (f) Debt instruments included within the FVTOCI category are measured initially as well as at each reporting date at fair value. Fair value movements are recognized in the other comprehensive income (OCI).

Debt instrument at FVTPL:

- (g) FVTPL is a residual category for debt instrument.
- (h) Any debt instrument, which does not meet the criteria for categorization as amortized cost or as FVTOCI, is classified as FVTPL. Debt instruments included within the FVTPL category are measured at fair value with all changes recognized in the Statement of Profit and Loss.

(i) In addition, the company may elect to designate a debt instrument, which otherwise meets amortized cost or FVTOCI criteria, as FVTPL. However, such election is chosen only if doing so reduces or eliminates a measurement or recognition inconsistency (referred to as 'accounting mismatch').

Derecognition of financial assets

- (j) A financial asset (or, where applicable, a part of a financial asset or part of a company of similar financial assets) is primarily de-recognized when:
 - · The rights to receive cash flows from the asset have expired, or
 - The company has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay
 the received cash flows in full without material delay to a third party under a 'pass-through' arrangement and
 either (a) the company has transferred substantially all the risks and rewards of the asset, or (b) the company has
 neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of
 the asset.
- (k) When the company has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if and to what extent it has retained the risks and rewards of ownership. When it has neither transferred nor retained substantially all the risks and rewards of the asset, nor transferred control of the asset, the company continues to recognized the transferred asset to the extent of the company's continuing involvement. In that case, the company also recognizes an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the company has retained.

[B] Financial liabilities and equity instruments

Initial recognition and measurement

(a) All financial liabilities are recognized initially at fair value plus transaction cost (if any) that is attributable to the acquisition of the financial liabilities which is also adjusted.

Subsequent measurement

(b) The measurement of financial liabilities depends on their classification, as described below:

Loans and borrowings

(c) After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortized cost using the Effective Interest Rate (EIR) method. Gains and losses are recognized in profit or loss when the liabilities are de-recognised as well as through the EIR amortization process. Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortization is included as finance costs in the statement of profit and loss.

Trade and other payables

(d) These amounts represent liabilities for goods or services provided to the company which are unpaid at the end of the reporting period. Trade and other payable are presented as current liabilities when the payment is due within a period of 12 months from the end of the reporting period. For all trade and other payables classified as current, the carrying amounts approximate fair value due to the short maturity of these instruments. Other payables filling due after 12 months from the end of the reporting period are presented as non- current liabilities and are measured at amortized cost unless designated as fair value through profit and loss at the inception.

Other financial liabilities at fair value through profit or loss:

(e) Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss. Gain or losses on liabilities held for trading or designated as at FVTPL are recognized in the profit or loss.

De-recognition of financial liabilities:

(f) A financial liability is de-recognition when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognized in the statement of profit or loss.

Offsetting

(g) Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognized amounts and there is an intention to settle on a net basis, to realize the assets and settle the liabilities simultaneously.

Impairment of financial assets

(h) The company assesses at each date of balance sheet whether a financial asset or a group of financial assets is impaired. Ind AS 109 requires expected credit losses to be measured through a loss allowance. The company recognized lifetime expected losses for all contract assets and / or all trade receivables that do not constitute a financing transaction. For all other financial assets, expected credit losses are measured at an amount equal to the 12-month expected credit losses or at an amount equal to the life time expected credit losses, if the credit risk on the financial asset has increased significantly since initial recognition.

2.18 FAIR VALUE MEASUREMENT:

- (a) The company measures financial instruments at fair value at each balance sheet date. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:
 - · In the principal market for the asset or liability, or
 - In the absence of a principal market, in the most advantageous market for the asset or liability.
- (b) The principal or the most advantageous market must be accessible by the company.
- (c) The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.
- (d) A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.
- (e) The company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs.
- (f) All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorized within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:
 - · Level 1: Quoted (unadjusted) market prices in active markets for identical assets or liabilities;
 - Level 2: Valuation techniques for which the lowest level input that is significant to the fair value measurement
 is directly or indirectly observable, or
 - Level 3: Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable.
- (g) For assets and liabilities that are recognized in the financial statements on a recurring basis, the company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorization (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

2.19 CASH & CASH EQUIVALENTS -

(a) Cash comprises cash on hand and demand deposits with banks. Cash equivalents are short-term balance (with an original maturity of twelvemonths or less from the date of acquisition), highly liquid investments that are readily convertible into known amounts of cash and which are subject to insignificant risk of changes in value.

2.20 SEGMENT -

(a) Operating segments are reported in a manner consists with the internal reporting provided to the management of the company.

Identification of segments

(b) The Company's management examines the Company's performance both from a product and geographic perspective. The Company's operating businesses are organized and managed separately according to the nature of products, with each segments representing a strategic business unit that offers different products and serves different markets. The analysis of the geographical segments is based on the areas in which major operating divisions of the Company operate.

Intersegment transfers

(c) The company accounts for intersegment sales on the basis of price charged for inter segment transfers.

Allocation of common cost

(d) Common allocable costs are allocated to each segment according to the relevant contribution of each segment to the total common cost.

Unallocated items

(e) Unallocated items include general corporate income and expenses items which are not allocated to any business segment.

Segment accounting policies

(f) The Company prepares its segment information in conformity with the accounting policies adopted for preparing and presenting the financial statement of the Company as a whole.

2.21 KEY SOURCES OF ESTIMATION UNCERTAINTY AND CRITICAL ACCOUNTING JUDGEMENTS -

- (a) In the course of applying the policies outlined in all notes under section 2 above, the company is required to make judgment, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factor that are considered to be relevant. Actual results may differ from these estimates.
- (b) The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future period, if the revision affects current and future period.

Useful lives of property, plant, and equipment

(c) Management reviews the useful lives of property, plant, and equipment at least once a year. Such lives are dependent upon an assessment of both the technical lives of the assets and also their likely economic lives based on various internal and external factors including relative efficiency and operating costs. Accordingly depreciable lives are reviewed annually using the best information available to the Management.

Provisions and liabilities

(d) Provisions and liabilities are recognized in the period when it becomes probable that there will be a future outflow of funds resulting from past operations or events that can reasonably be estimated. The timing of recognition requires application of judgment to existing facts and circumstances which may be subject to change. The amounts are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability.

Contingencies

(e) In the normal course of business, contingent liabilities may arise from litigation and other claims against the company. Potential liabilities that are possible but not probable of crystallizing or are very difficult to quantify reliably are treated as contingent liabilities. Such liabilities are disclosed in the notes but are not recognized.

Fair value measurements

(f) When the fair values of financial assets or financial liabilities recorded or disclosed in the financial statements cannot be measured based on quoted prices in active markets, their fair value is measured using valuation techniques including the DCF model. The inputs to these models are taken from observable markets where possible, but where this is not feasible, a degree of judgment is required in establishing fair values. Judgments include consideration of inputs such as liquidity risk, credit risk and volatility".

Taxes

(g) Deferred tax assets are recognized for unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilized. Significant management judgment is required to determine the amount of deferred tax assets that can be recognized, based upon the likely timing and the level of future taxable profits together with future tax planning strategies.

The Company has funded the gratuity liability ascertained on actuarial basis, wherein every employee who has completed five years or more of service is entitled to gratuity on retirement or resignation or death calculated at 15 days salary for each completed year of service, subject to maximum of Rs. 20 lakhs per employee. The vesting period for gratuity as payable under The Payment of Gratuity Act is 5 years.

Interest Rate risk: The plan exposes the Company to the risk of fall in interest risk. A fall in interest rates will result in an increase in the ultimate cost of providing the above benefit and will thus result in an increase in the value of the liability (as shown in financial statements).

Liquidity Risk: This is the risk that the Company is not able to meet the short term gratuity payouts. This may arise due to non-availability of enough cash / cash equivalent to meet the liabilities or holding of illiquid assets not being sold in time.

Demographic Risk for Employee Benefits: The Company has used certain mortality and attrition assumptions in valuation of the liability. The Company is exposed to the risk of actual experience turning out to be worse compared to.

Salary Escalation Risk: The present value of the defined benefit plan is calculated with the assumption of salary increase rate of plan participants in future. Deviation in the rate of increase of salary in future for plan participants from the rate of increase in salary used to determine the present value of obligation will have a bearing on the plan's liability.

Regulatory Risk for Employee Benefits: Gratuity benefit is paid in accordance with the requirements of the Payent of Gratuity Act, 1972 (as amended from time to time). There is a risk of change in regulation requiring higher gratuity payouts (e.g. increase in the maximum limit on gratuity of Rs. 20,00,000).

Fire Incident at Dispatch Department:

On May 17, 2024, a fire occurred at the dispatch department of the company. This incident resulted in the loss of some assets. Due to the nature of the damage, the management could not specifically identify the cost of the assets lost. The following method was employed to estimate the value of the lost assets.

Identification of Replacement Cost:

A valuer was consulted to identify the cost of acquiring similar new assets as of the date of estimation.

Adjustment for Inflation:

The identified cost was adjusted to reflect the inflation effect, with an estimated annual inflation rate of 7%.

Depreciation Calculation:

Depreciation was calculated on the adjusted cost to determine the Written Down Value (WDV) of the lost assets. The assets wer e originally put to use at the end of FY 2016-17.

Based on the above method, the WDV of the lost assets was calculated to be Rs. 6,86,119.00.

Insurance Claim and Financial Impact

The company received an insurance claim of Rs. 881,727.00 for the assets lost due to the fire. Consequently, a gain of Rs. 195,607.00 has been recognized, which will be booked in the financial year 2024-25.

Summary of Calculations

- Replacement Cost of New Assets: As per valuer's assessment.
- Inflation Adjustment: Applied a 7% annual inflation rate.
- Depreciation and WDV Calculation: Based on the above adjustments, the WDV of the lost assets was determined to be Rs. 686.119.00.
- Insurance Claim Received: Rs. 881,727.00.
- Gain Recognized: Rs. 195,607.00 (to be booked in FY 2024-25).
