Sub: Record Date for issue of shares of State Bank of India to eligible shareholders of State Bank of Bikaner and Jaipur.

With reference to our letter dated 23rd February, 2017, this is to inform you that the Executive Committee of the Board of Directors of State Bank of Bikaner and Jaipur has approved and fixed Friday, the 17th March, 2017 as the Record Date for issue of shares of State Bank of India to eligible shareholders of State Bank of Bikaner and Jaipur entitled to receive 28(Twenty Eight) equity shares of face value of Rs. 1 (One) each of State Bank of India, fully paid up for every 10 (Ten) equity shares of face value of Rs. 10(Ten) each held by them in State Bank of Bikaner and Jaipur, pursuant to the "Acquisition of State Bank of Bikaner and Jaipur Order, 2017" (the Order) issued by the Government of India vide Gazette Notification No.: G.S.R. 156 (E) dated 22nd February, 2017. The said Order shall come into force from Saturday, the 1st April, 2017 (Effective Date).

Please note that in terms of Para 6 (c) of the said Order, trading in the shares of State Bank of Bikaner and Jaipur shall cease on the Record Date (i.e. 17th March, 2017) and all shares of State Bank of Bikaner and Jaipur shall be deemed to be automatically cancelled, extinguished and be of no effect as and from 1st April, 2017 (Effective Date).
