Sub: Intimation of reasons for Non-compliance with SEBI (LODR) Regulations - reg.

Dear Sir/Madam,

With reference to the captioned subject, we hereby inform you that the Company is undergoing CIRP w.e.f. 15/11/2022 and the powers of the Board of Directors have been suspended and vested with Resolution Professional of the Company.

As submitted to the Exchange earlier due to commencement of CIRP, there has been financial distress and huge dislocation in the management of day to day affairs of the company caused mainly due to non-availability / resignation of KMP / and lack of concerned staff required to handle these specialised jobs.

Due to the Company's financial position, Annual Listing Fees to both BSE & NSE could not be paid, the Company is not in a position to pay the Annual Custodial Fees to NSDL/CDSL and RTA fees, due to which the Company could not receive benpos /Shareholding patterns/ required information to make necessary compliances.

Also due to pending audit / submission of audited results for March, 2023, the limited review of June, September and December 2023 quarters results, is not yet completed and not able to submit Unaudited Financial results for the captioned quarters. Audit for the FY-2023-2024 is also pending. Once the Audit is completed, the company will be filing the pending Financials Results and also reports of Auditors.
