The Company had initiated arbitration proceedings in June, 2019 against Nagar Palika, Nokha for recovery of its legitimate dues against work done at Ward No. 5 and Ward No. 29, Nokha, Rajasthan as follows:</p> <p>(a) ₹14,11,200 for the O&M work of a Sewage Treatment Plant (STP) along with interest @ 18% p.a. compounded monthly from the date of filing till the realisation.</p> <p>(b) ₹7,50,000 as a security deposit along with interest @ 24% p.a. compounded monthly from the date of filing till the realisation.</p> <p>(c) ₹2,50,000 for an unutilized earnest money deposit along with interest @ 24% p.a. compounded monthly from the date of filing till the realisation.</p> <p>(d) ₹15,00,000 as damages on account of losses suffered by the Company.</p> <p>(e) Costs of arbitration proceedings</p> <p>2. Delhi International Arbitration Centre had passed an award dated 21.01.2021 in favour of the Company and against Nagar Palika, Nokha.</p> <p>In the said arbitral award, the Nagar Palika, Nokha was ordered to pay:</p> <p>(a) ₹14,11,200 for the O&M work of a Sewage Treatment Plant (STP) at Ward No. 5, with compound interest with monthly rests at three</p>

		<p>times the rate notified by the Reserve Bank from May 23, 2016 till realisation.</p> <p>(b) ₹7,50,000 as a security deposit for work order No. 1388 along with the interest @15% per annum from 09.04.2016 till realisation.</p> <p>(c) ₹2,50,000 for an unutilized earnest money deposit for work order No. 1394 along with interest @ 15% per annum from 11.08.2017 till realisation.</p> <p>(d) Costs of arbitration proceedings of approx. ₹4,80,000 were also granted in favour of the Company.</p> <p>3. That Nagar Palika, Nokha had challenged the said award dated 21.01.2021 before the Hon'ble Patiala House Courts New Delhi by way of an Application under Section 34 of the Arbitration and Conciliation Act, 1996, being OMP (COMM) No. 178/2023.</p> <p>4. That vide Judgment and Order dated 24.01.2024, Hon'ble Patiala House Courts New Delhi was pleased to dismiss the said Application under Section 34 of the Arbitration and Conciliation Act, 1996, being OMP (COMM) No. 178/2023.</p> <p>5. That Nagar Palika, Nokha had challenged the said Judgment and Order dated 24.01.2024 before the Division Bench of the Hon'ble Delhi High Court, New Delhi by way of an Appeal under Section 37 of the Arbitration and Conciliation Act, 1996, being FAO (COMM) No. 25/2025.</p>
