SCRUTINIZER'S REPORT

The Chairman,

The Chairman of 54th e-Annual General Meeting (“54th e-AGM”, “AGM” or e-AGM”) of the Members of Mysore Petro Chemicals Limited (CIN: L24221KA1969PLC001799), held on Thursday, 19th September, 2024 at 3:00 p.m. through Video Conferencing (“VC”) / Other Audio-Visual Means (“OAVM”) facility.

Subject: Scrutinizer’s Report on voting through e-voting for Annual General Meeting in terms of Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management & Administration) Rules, 2014.

1. I, Martinho Ferrao, Company Secretary in Practice and Proprietor of Martinho Ferrao & Associates, Company Secretaries (FCS: 6221 and C.P. No.: 5676), Mumbai, have been duly appointed as the Scrutinizer by the Board of Directors of Mysore Petro Chemicals Limited (“the Company”) at their meeting held on 26th July, 2024 to scrutinize the e-voting conducted in respect of the Resolutions as circulated/stated in the Annual General Meeting Notice dated 26th July, 2024 ('Notice') in a fair and transparent manner.
2. The item for which approval of the Members of the Company was sought as stated in the Notice is mentioned hereunder: -

In compliance with the provisions of Sections 108, 110 and other applicable provisions, if any, of the Companies Act, 2013 (the 'Act') read with the Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules"), made thereunder, Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("the SEBI Listing Regulations"), the Secretarial Standard on the General Meetings ('SS-2') issued by the Institute of Company Secretaries of India each as amended, read with the General Circular Nos. 14/2020 dated 8th April, 2020, 17/2020 dated 13th April, 2020, 22/2020 dated 15th June, 2020 and 09/2023 dated 25th September, 2023 issued by the Ministry of Corporate Affairs (collectively the "MCA Circulars") and Circular Nos. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated 11th July, 2023 and SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated 7th October, 2023 issued by the Securities and Exchange Board of India for seeking approval of the Members of the Company to transact the Business as set out in the Notice of Annual General Meeting dated 26th July, 2024, by way of remote e-voting process and e-voting at the time of Annual General Meeting.
4. The Management of the Company is responsible to ensure the compliance of the requirements of the Act and Rules relating to remote e-voting and e-voting during the 54th AGM on the proposed resolutions contained in the Notice. My responsibility as a Scrutinizer for the process of voting through remote e-voting and e-voting during the 54th e-AGM is to ensure that the voting process is conducted in a fair and transparent manner and is restricted to making a Scrutinizer's Report for the votes cast in "favour" or "against" on the resolutions proposed in the Notice, based on the reports generated from the e-voting system provided by National Securities Depository Limited (NSDL), the agency authorized under the Rules and engaged by the Company to provide platform for voting through remote e-voting and e-voting during the 54th e-AGM and platform for VC/ OAVM facility for participation in the 54th e-AGM.
5. The Company has confirmed that the electronic copy of the Notice and Explanatory Statement along with the process of remote e-voting in terms of the MCA and SEBI Circulars were sent to those members whose e-mail addresses were registered with the Company/Depositories and whose names appeared in the Register of Members of the Company or Register of Beneficial Owners maintained

by the Depositories as on Friday, 16th August, 2024. In order to facilitate those Members who had not yet registered their email IDs, a proper procedure was laid down to get their email IDs registered with the Registrar and Transfer Agent so that they could also participate in the e-voting facility extended by the Company.

6. Prior to dispatch of the Notice and Annual Report 2023-24, the requisite advertisements pursuant to the Rules and the MCA Circulars were published by the Company on 21st August 2024 in Financial Express (English) and Samyukta Karnataka (Kannada) - Bengaluru Edition. Post-dispatch of the Notice and Annual Report 2023-24, the requisite advertisement pursuant to the Rules and the MCA Circulars was published by the Company on 26th August 2024 in "Financial Express (English) and Samyukta Karnataka (Kannada) - Bengaluru Edition.
7. The Company has engaged the services of National Securities Depository Limited, as the Electronic Voting Service Provider (hereinafter referred to as "NSDL" or "EVSP") who had made necessary arrangements to facilitate e-voting by the Members of the Company on their website www.evoting.nsdl.com/. Members were required to communicate their assent or dissent only through remote e-voting system in terms of the said Circulars. The remote e-voting was kept open from Monday, 16th September, 2024 (9:00 a.m.) to Wednesday, 18th September, 2024 (5:00 p.m.)
8. The Company and the EVSP had uploaded the Notice together with the explanatory statement on their respective websites viz. www.mysorepetro.com and www.evoting.nsdl.com/. The Notice was also uploaded on the website of the stock exchange where the securities of the Company is listed viz. www.bseindia.com. The Company and the EVSP have complied with all the necessary formalities specified under the Act, the Rules and the Circulars issued in this regard
9. The total number of members as on the Cut-off date was 5728. The voting period commenced on Monday, 16th September, 2024 at 9.00 a.m. and ended on Wednesday, 18th September, 2024 at 5.00 p.m. For those Members whose email IDs were not available, a Public Notice with regard to the Company's Annual General Meeting Notice was published on Wednesday, 21st August, 2024 in Financial Express (English) and Samyukta Karnataka (Kannada) - Bengaluru Edition providing the requisite information and contact details for registering email IDs and queries on e-voting.
10. The Members of the Company as on the "cut-off" date, i.e. 12th September, 2024 (end of day) were entitled to avail the facility of remote e-voting or voting during the AGM on all the resolutions proposed in the Notice.

11. At the end of the remote e-voting period on, 18th September, 2024 at 5:00 p.m., the voting portal of the service provider i.e. NSDL was blocked forthwith.
12. At the 54th AGM of the Company held on, 19th September, 2024, the Chairman at the end of discussions on the resolutions announced that the facility for e-voting is available for voting by the Members attending the Meeting through VC / OAVM facility and who have not participated in the remote e-voting and who are not otherwise debarred from voting.
13. Immediately after the conclusion of the e-voting during the AGM on 19th September, 2024, the register containing the details of the e-voting, vis-a-vis the compilation of the data containing the Member's name, DP ID, Client ID and/or folio number, number of shares held, number of votes exercised, votes in favour, votes against were unblocked by me in the presence of two witnesses (who are not in employment of the Company). Subsequently, the votes cast were reconciled with the records maintained by the Company and the authorizations lodged with the Company.
14. Thereafter, the information regarding list of the Members, who voted "for" or "against" or "abstained" and such other requisite details on each of the resolutions that were put to vote, were derived from the report generated from the e-voting website of NSDL, including votes cast by the Members during the e-AGM.
