We wish to inform you that the Company pursuant to Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements), Regulations 2015 requires to publish its Audited Standalone and Consolidated Financial Results for the quarter and year ended on 31<sup>st</sup> March, 2019 ('Financial Results') on or before 30<sup>th</sup> May, 2019.


Hon'ble National Company Law Tribunal vide their order delivered on 10th September, 2018 has initiated Corporate Insolvency and Resolution Process in the Company. Further financials of all subsidiaries/Associates/JVs are not yet made available for the purpose of consolidation. In view of this the company is not in position to publish financial results and thus hereby request to grant extension of four weeks for its publication.

You are further requested to grant waiver from imposition of penalty (if any) since the situation is beyond the control of the company.
