ढाका(ईएमएस)। शेख हसीना सरकार का तख्तापलट के कुछ ही मिनटों में जेल से रिहा हुईं पूर्व पीएम खालिदा जिया की पार्टी ने सभी आरोपों को नकार दिया है। बांग्लादेश नेशनलिस्ट पार्टी (बीएनपी) की ओर से कहा गया है कि देश में सब सुरक्षित हैं और किसी के खिलाफ कोई हिंसा नहीं हैं। बीएनपी के महासचिव मिर्जा इस्लाम आलमगीर ने भारतीय मीडिया को बाकायदा न्यौता देते हुए कहा कि आप खुद ढाका आइए और खुद देखिए कि बांग्लादेश में क्या हुआ है। बता दें कि हाल ही में अंतरिम सरकार प्रमुख मोहम्मद यूनुस ने अल्पसंख्यकों पर हमले की निंदा की थी। बता दें कि बांग्लादेश में अल्पसंख्यकों (हिंदुओं) के खिलाफ हिंसा को लेकर पिछले कई दिनों में ढाका ही नहीं बल्कि विदेशों में भी बड़े पैमाने पर विरोध पदर्शन हो रहे हैं।



शेख हसीना को नया झटकाः बांग्लादेश में उनके खिलाफ हत्या का मामला दर्ज

ढाका। बांग्लादेश की अपदस्थ प्रधानमंत्री शेख हसीना और छह अन्य के खिलाफ पिछले महीने हुई हिंसक झड़पों के दौरान किराने की एक दुकान के मालिक की मौत को लेकर हत्या का मामला दर्ज किया गया है। मंगलवार को मीडिया की खबरों में यह जानकारी सामने आई है। नौकरी में आरक्षण की विवादास्पद व्यवस्था को लेकर अपनी अवामी लीग नीत सरकार के खिलाफ व्यापक विरोध प्रदर्शन के बाद पिछले सप्ताह इस्तीफा देकर भारत भाग गयीं हसीना (७६) के खिलाफ दर्ज किया गया यह पहला मामला है। ढाका ट्रिब्यून अखबार की खबर के मुताबिक, यह मामला किराने की दुकान के मालिक अब् सईद के शुभचिंतक ने दर्ज कराया है, जिनकी मोहम्मदपुर में आरक्षण आंदोलन के समर्थन में १९ जुलाई को निकाले गए जुलूस के दौरान पुलिस की गोलीबारी में मौत हो गई थी। अन्य आरोपियों में अवामी लीग के महासचिव ओबैदुल कादर, पूर्व गृह मंत्री असद्ज्जमां खान कमाल और पूर्व पुलिस महानिरीक्षक चौधरी अब्दुल्ला अल मामून शामिल हैं। रिपोर्ट के अनुसार, इनके अलावा, कई उच्च पदस्थ पुलिस अधिकारियों और सरकारी अधिकारियों को भी मामले में आरोपी बनाया गया है।



बांग्लादेश सरकार ने हिंदओं पर हमलों के लिए मांगी माफी

ढाका। बांग्लादेश में हिंदुओं पर हुए हमलों और मंदिरों में तोड़फोड़ के लिए सरकार ने माफी मांगी है। गृह मंत्रालय के प्रमुख ब्रिगेडियर जनरल (रिटायर्ड) मुहम्मद सखावत हरौन ने कहा, पिछले हफ्ते हुई हिंसा में बहुत से स्थानों पर हिंदुओं पर हमले हुए, उसके लिए सरकार को खेद है। इस हिंसा में जिन्हें नकसान हुआ और जो मंदिर तोडे या जलाए गए हैं उनकी क्षतिपूर्ति व निर्माण के लिए सरकार आर्थिक मदद देगी। अंतरिम प्रधानमंत्री मुहम्मद यूनुस मंगलवार को हिंसा पीड़ित समुदायों के प्रमुख लोगों से मिलेंगे। उन्होंने भी अल्पसंख्यकों को पूरी सुरक्षा का मरोसा दिया है। ज्ञात हो, यूनुस को दिए बधाई संदेश में पीएम नरेन्द्र मोदी ने हिंदुओं पर हो रहे हमलों पर चिंता जताई थी ।

रूस के 1000 वर्ग किमी इलाके पर यूक्रेन का कब्जा

कीव-मास्को। युक्रेन ने रूस के 1.000 वर्ग किमी से ज्यादा इलाके पर कब्जा कर लिया है। उठठ के मुताबिक एक सप्ताह पहले युक्रेनी सैनिकों ने रूस के कुर्स्क इलाके पर हमला किया था। तब से यहां के करीब 28 गांवों पर कब्जा कर चुके हैं।

कर्स्क में टैंकों और तोपखानों से लैस करीब एक हजार यूक्रेनी सैनिक 6 अगस्त को दाखिल हुए थे। इसके बाद रूस ने 8 अगस्त को ही यहां इमरजेंसी लगा दी थी। रूसी





राष्ट्रपति व्लादिमीर पुतिन ने इसे युक्रेन की उकसाने वाली हरकत बताया है। उन्होंने अपने रक्षा अधिकारियों को युक्रेनी सेना को रूसी इलाके से खदेडने का आदेश दिया है।

पुतिन बोले- यूक्रेन के साथ कोई समझौता नहीं करेंगे-पुतिन ने कहा कि यक्रेन, रूसी इलाके पर कब्जा कर सीजफायर समझौते के लिए अपना पक्ष मजबूत करना चाहता है, लेकिन हम उन लोगों के साथ कोई समझौता नहीं करने वाले हैं। पुतिन ने युक्रेन पर रूसी नागरिकों की हत्या करने और न्यक्लियर पावर प्लांट के नजदीक हमला करने का आरोप लगाया।यूक्रेन के राष्ट्रपति जेलेंस्की ने बीते रविवार को माना था कि

युक्रेन ने रूसी इलाके में घुसकर हमला किया है। एक वीडियो जारी कर उन्होंने कहा कि रूस ने युक्रेन पर कुर्स्क से 2,000 से ज्यादा बार हमले किए। हम रूस को बताना चाहते हैं कि हम भी जवाब दे सकते हैं। उन्होंने कहा कि युक्रेन न्याय के लिए लड रहा है। उन्होंने यक्रेनी सैनिकों का शक्रिया अदा भी किया। रूस ने शुक्रवार तक युक्रेनी सीमा से सटे कुर्स्क में कम से कम 250 वर्ग किलोमीटर का इलाका गंवा दिया है। यूक्रेनी सैनिकों का अगला टारगेट रूसी शहर सुद्जा है। सोशल मीडिया पर कई वीडियो वायरल हैं. जिनमें युक्रेनी सैनिक इमारतों पर रूसी झंडा हटाकर अपने देश का झंडा लगा रहे हैं।
