Dear Sir / Madam.

This is in reference to the above mentioned subject to which we clarify and submit as under:

Oriental Bank of Commerce, since merged with Punjab National Bank (PNB), had filed an application for initiating CIRP under IBC which was admitted vide NCLT Order dated 28th November 2022. The NCLT Order is under appeal before NCLAT and the matter is pending. Meanwhile, Hon'ble High Court of Orissa, by way of an Interim Order dated 21st December 2023, stayed the operation of the said NCLT Order dated 28th November 2022.

Subsequent to such interim stay, NCLT Cuttack recorded the same in its Order dated 13 February, 2023, a copy of which is enclosed.
