- 3. The non compliance has duly been rectified by re-filing of the certificate on February 3, 2024 23:33:25 under Regulation 45(3) as was received from practicing chartered accountant Punit Pandey & Associates stating compliance with conditions provided in Regulation 45(1) vide dated January 13, 2024 for your records.

We wish to inform that this certificate was previously, duly been submitted as part of the BSE Name change query/remarks consequent to which only the name change was approved.

Also, the certificate was also duly been placed before the members for ratification in the AGM held on Friday, August 9, 2024, which was duly been approved/ratified. The stock exchange was duly been informed of in the outcome of AGM.

Sub: Warning for Non-Compliance of Regulation 45(3) of SEBI LODR.

This is with reference to the Name change application submitted by the Company dated May 03, 2024 seeking Exchange's approval for changing its name from Eastern Logica Infoway Ltd to LOGICA INFOWAY LIMITED.

It was observed that the Company was in Non-compliance with Reg. 45 (3) of SEBI LODR and the Company had provided ratification letter in that regard. The application was processed and the details of non-compliance was referred to SEBI. It is observed that the Company is yet to ratify the non-compliance w.r.t Reg. 45 (3).
