Sub: Outcome of Meeting of Board of Directors of Apollo Micro Systems Limited held on 09th <u>January</u>, 2025 pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations")

In furtherance of the intimation dated January 04, 2025, and pursuant to Regulation 30 of the SEBI Listing Regulations, we wish to inform you that the Board of Directors of the company, at its meeting held today i.e., Thursday, 09th January, 2025 at the registered office of the Company have, inter alia considered and approved, the following items together with other agenda items:

1. To consider and approve the increase of Authorized capital from the existing ₹ 36,00,00,000/-(Rupees Thirty Six Crores Only) divided into 36,00,00,000 (Thirty Six Crores Only) Equity Shares of ₹1 /- (Rupees One Only) each to ₹ 45,00,00,000/- (Rupees Forty Five Crores Only) divided into 45,00,00,000 (Forty Five Crores Only) Equity Shares of ₹ 1/- (Rupee One Only) each by the addition there to a sum of ₹ 9,00,00,000/- (Rupees Nine Crores Only) divided into 9,00,00,000 (Nine Crores) Equity Shares of ₹ 1/- (Rupee One Only) each ranking pari-passu in all respects with the existing shares of the Company.

Consequent to the aforesaid increase in Authorised Share Capital, Clause V of Memorandum of Association of the Company shall be altered as under:

"V. The Authorized Shares Capital of the Company is $\stackrel{?}{\underset{\sim}} 45,00,00,000/$ - (Rupees Forty Five Crores Only) divided into 45,00,00,000/- (Rupees Forty Five Crores Only) Equity Shares of $\stackrel{?}{\underset{\sim}} 1/$ - (Rupee One only) each with a right to issue shares for consideration other than cash and to increase and reduce the capital and to divide or consolidate or cancel the shares in the capital for the time being into several classes and attach thereto respectively such rights and conditions in any manner the Board of Directors may deem fit from time to time"

2. To issue upto 3,34,18,806 (Three Crores Thirty Four Lakhs Eighteen Thousand Eight Hundred and Six only) Equity shares of Face Value ₹ 1/- (Rupee One only) each at a price of ₹ 114/- (Rupees One Hundred and Fourteen Only) ("Preferential Allotment Price") each including premium of ₹ 113/- (Rupees One Hundred and Thirteen only) per share aggregating to ₹ 3,80,97,43,884 (Rupees Three Hundred Eighty Crores Ninety Seven Lakhs Forty Three Thousand Eight Hundred and Eighty Four only) on a preferential basis ("Preferential Allotment") for cash consideration to the select group of persons (the "Investors") who do not belong to Promoter & Promoter Group of the Company ("the Proposed Allottees"), enclosed as Annexure I herein by way of preferential issue on a private placement basis, in accordance with the provisions of Section 42 and Section 62(1)(c) of the





Companies Act, 2013, as amended ("Act") read with Companies (Prospectus and Allotment of Securities) Rules, 2014, as amended ("Rules"), Chapter V of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, Listing Regulations and such other acts / rules / regulations as maybe applicable and subject to the approval of the regulatory/ Statutory Authorities and the members of the Company. Upon issue of Equity Shares in accordance herewith, 100% of the Preferential Allotment Price shall be payable at the time of application to the Equity Shares.

- 3. To issue upto 3,81,67,059 (Three Crores Eighty One Lakhs Sixty Seven Thousand and Fifty Nine Only) convertible equity warrants of the Company each convertible into, or exchangeable for, one Equity Share of Face Value ₹ 1/- (Rupee One only) each within the period of 6 (Six Months) in accordance with the applicable law ("Warrants") at a price of ₹ 114/- (Rupees One Hundred and Fourteen Only) each (including the warrant subscription price and the warrant exercise price) aggregating upto ₹ 4,35,10,44,726/- (Indian Rupees Four Hundred Thirty Five Crores Ten Lakhs Forty Four Thousand Seven Hundred and Twenty Six only) to Promoter Group and to certain identified Non- Promoter Persons or Entities ("the Proposed Allottees"), enclosed as Annexure II herein by way of preferential issue on a private placement basis, in accordance with the provisions of Section 42 and Section 62(1)(c) of the Companies Act, 2013, as amended ("Act") read with Companies (Prospectus and Allotment of Securities) Rules, 2014, as amended ("Rules"), Chapter V of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, Listing Regulations and such other acts / rules / regulations as maybe applicable and subject to the approval of the regulatory/ Statutory Authorities and the members of the Company ("Warrants Issue"). Upon issue of Warrants in accordance herewith, an amount equivalent to 25% (Twenty-Five per cent) of the total issue size shall be called upfront from the proposed allottees;
- 4. Appointment of Acuité Ratings & Research Limited a SEBI registered Credit Rating Agency as the monitoring agency to monitor the use of the proceeds of the Preferential Issue ("Monitoring Agency");
- 5. To hold the Extra-Ordinary General Meeting of the Members of the Company on Tuesday, 04th February, 2025 through video conferencing and / or other audio-visual means;
- 6. To fix Tuesday, 28th January, 2025 as the cut-off date for determining the eligibility of the Members entitled to vote at the ensuing Extraordinary General Meeting of the Company by electronic means or in the general meeting scheduled to be held on Tuesday, 04th January, 2025 through video conferencing and / or other audio-visual means;
- 7. Appointment of Ms. Sridevi Madati (M No: F6476) (CP No: 11694), M/s. MNM & Associates, Practicing Company Secretaries, Hyderabad as the Scrutinizer for scrutinizing the E- voting process in accordance with the provisions of the Companies Act 2013 & rules made there under and provide the consolidated report on the votes cast during the EGM and through remote e-voting "in favor" or "against" the resolutions stated in the notice sent to the members for the Extraordinary General Meeting.
