15 August 2000
In Shillong, two posts of 65 Battalion of CRPF, Mukharpoint Bara Bazar and Dreamland Cinema Police Bazaar, were separated by 500 meters. On 15th August 2000, insurgents launched coordinated attacks on both locations. CRPF troops at Mukharpoint Bara Bazar repelled the attackers with a strong response. Minutes later, the Dreamland Cinema post was similarly attacked, and again, CRPF retaliated effectively. During the crossfire, HC Arun Kumar Singh was struck in the chest. Despite repelling the attack, HC Arun Kumar Singh succumbed to his injuries and was martyred.

95 Battalion of CRPF was deployed in Nagaland to counter the insurgents, a major threat to the state's peace. Following an attack on 15th August 1998, security at the NPPCL factory camp was heightened. While checking sentries, Shaheed Head Constable Mool Chand was ambushed and gravely injured by militants. Despite our troops returning fire, the militants escaped. Shaheed HC Mool Chand later succumbed to his injuries, making the ultimate sacrifice in the line of duty.

15 August 1999
52 Battalion of CRPF was deployed in Manipur to counter insurgent activities that had intensified across the state. During an operation in Bishnupur, Imphal, on 15th August 1999, Shaheed Constable Ajeet Kumar Singh, Shaheed Constable B. R. Sable, and Shaheed Constable Ranjeet Kumar Mondal bravely led an assault, inflicting heavy losses on the insurgents. Despite their valiant efforts, they were severely injured and made the ultimate sacrifice in the line of duty. The nation will forever remain indebted to them and their families.

15 August 1965
On the night of 15-16 August 1965, a post of 13 Battalion of CRPF at Yumarg was attacked by 100-150 raiders at around 0045 hrs. Constable Gudit Singh, on sentry duty, was severely injured by enemy fire. Despite his injuries, he fought bravely, alerted the camp, and made the ultimate sacrifice. For his conspicuous gallantry, he was posthumously awarded the President's Police Medal and Fire Services Medal for Gallantry.

15 August 1993
11 Battalion of CRPF was deployed in Jammu and Kashmir for anti-terrorist operations against militants supported from across the border. On 15th August 1993, its troops launched an operation in Srinagar, leading to a fierce encounter. Shaheed Constable Salam Iboiyama Singh, who led the attack, sustained severe injuries but continued firing until he made the ultimate sacrifice. Such a display of gallantry and sacrifice is rarely

The festivities of 15th August 2016 were disrupted when militants hurled grenades and opened fire on 28 Bn CRPF troops at Nowhatta Chowk, injuring eight CRPF and one JKP personnel. Shri Pramod Kumar, Commandant of 49 Battalion of CRPF, immediately launched a special operation to eliminate the terrorists. Leading his team into a fierce gun battle, he neutralized two heavily armed militants. Despite sustaining grievous head injuries, he continued to fight until he was rushed to the hospital, where he succumbed to his injuries. For his unparalleled leadership and courage, Shri Pramod Kumar was posthumously awarded the Kirti Chakra. The nation will forever remain indebted to him and his family.

On 15th August 2007, troops of 133 Battalion of CRPF were on a Road Opening Patrol when insurgents ambushed them near Parabamanipara village, PS-Ganganagar, Dhalai district. The troops quickly took positions and returned fire, advancing toward the insurgents using fire-and-move tactics. As the insurgents fled, Shaheed Constable Chandrajeet Yadav, disregarding his own safety, emerged from cover to pursue them. Tragically, he was struck by enemy fire and attained martyrdom en route to hospital.
