The Board of Directors of the Company at their meeting held today, i.e. Wednesday, September 04, 2024 noted and took on record that the Company had issued First and Final Call Money Notice dated, June 11, 2024 and Reminder 1 Notice dated July 22, 2024 for payment of First and Final Call Money of Rs. 10/- per partly paid-up equity share (consisting of Rs. 5 per share towards share premium and Rs.5 per share towards face value) to the holders of 1,93,93,544 partly paid-up equity shares (paid-up Rs.10/- each) of the Company as on the Record Date i.e. May 31, 2024.
