<u>Sub:-</u> Intimation Pursuant to Regulation 30 of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015.

This is in reference to our letter dated 01/04/2024, pursuant to Regulation 30 of the SEBI (LODR), wherein it was informed that the Company has received an order dated March 28, 2024, from the Income Tax Department for the Assessment Year 2018-19 making a tax demand of Rs. 17,17,49,280/-.

In continuation of the said letter, we would like to inform you that the Company has received a revised order dated 15.10.2024, which was received on 22.11.2024 via E-mail, from the Deputy Commissioner of Income Tax, Circle- 4(1), Kolkata, whereby the Income tax Department had reduced the tax demand from Rs. 17,17,49,280/- to Rs. 10,17,17,149/- for the Assessment Year 2018-19. The reduction in the tax demand was due to an error in the computation of interest under section 234B, which resulted in an excess levy of interest in the previous order dated 28.03.2024.

It may also be noted that an appeal against the said order which is now revised by the Income Tax Department is still pending before the Commissioner of Income Tax (Appeals)

The detail required under Regulation 30 of the SEBI (Listing Obligation and Disclosure Requirements) Regulation, 2015 read with SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 9, 2015, is given in Annexure A.
