To the Board of Directors of My Money Securities Limited

- We have reviewed the accompanying Statement of unaudited financial results of My Money Securities Limited (the "Company") for the quarter ended September 30, 2024 and year-to-date results for the period from April 1, 2024 to September 30, 2024 (the "Statement").
- 2. This Statement, which is the responsibility of the Company's Management and approved by its Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013 as amended, read with relevant rules issued there under and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").
