The chatbot—developed by the state government, the Prayagraj Mela Authority, and the Uttar Pradesh Development Systems Corporation has deployed the open-source large language model (LLM) built by Ola's AI venture Krutrim, and is accessible in at least 10 languages.

Akanksha Rana, officer on special duty at the Maha Kumbh, told FE: "We have moved most of the fair's operations from offline to online—everything from sanitation to camps, tracking inventory, mechanisms of monitoring, security and surveillance, is online."

Prakhar Srivastava, who leads digital transformations and partnerships for the Prayagraj Mela Authority, said: "For the Maha Kumbh, we have integrated tech with most a task. For that, the manageemergency services. Besides a detailed website in Hindi and English, the entire venue will be WiFi-enabled. A Vi spokesperson said the telco has enhanced network capacity by adding 30 new sites at Triveni Sangam as well as around 40 macro and high-powered small cells covering all major points in nearby areas. Additionally, 32 km of fibre has been deployed to strengthen backhaul connectivity. For all those missing the

Trump tariffs: Auto suppliers rethink production plans

ABHIRUP ROY Las Vegas, January 9

GLOBALAUTO SUPPLIERS are

working out how much of their production can be moved to the US, or closer to it, as a defence against tariffs promised by President-elect Donald Trump, according to industry executives at CES in Las Vegas.

The auto industry has already experienced 8 years of US protectionism, from real and threatened tariffs during Trump's first term and then more tariffs and the US Inflation Reduction Act under President Joe Biden.

Trump has vowed to go further, imposing a blanket tariff of 10% on global imports into the US and a 60% tariff on Chinese goods. In late November, he specifically pledged a 25% tariff on imports from Canada and Mexico. Such high tariffs would be hard to pass on to consumers

and would render many auto parts made in lower-cost markets uneconomical, or in the case of China make it virtually impossible to sell products in the US. "Anyone can do the math,"

Paul Thomas, North America president for Bosch, said. "If it's 10%, 20%, 60% (tariffs)...you have to say, 'OK, how many scenarios make sense for that and which ones do we act on?"

Speaking on the sidelines of the CES conference, Thomas gave a theoretical example of a generic electronic control unit that Bosch may currently make in Malaysia or a similar market, but now "we're looking at doing
