
Global manufacturing footprint



Precision Group – Global Footprint




Financial Performance – Standalone Q2 FY25







Financial Performance – Consolidated Q2 FY25






Machined Camshafts vs Camshafts Casting - Q1FY25 vs Q2 FY25











Individual Income
