SUMMARY OF PROCEEDING OF 14th ANNUAL GENERAL MEETING

The 14th Annual General Meeting of Sanghvi Brands Limited was held on Monday, 30th September 2024 at 2.00 p.m. (IST) through Video Conferencing ("VC") and Other Audio-Visual Means ("OAVM").

The meeting was held in compliance with the General Circular nos. 20/2020, 14/2020, 17/2020 issued by the Ministry of Corporate Affairs ("MCA") and Circular number SEBI/HO/CFD/CMD1/CIR/P/2020/79 issued by the Securities and Exchange Board of India ("SEBI") and as per the applicable provisions of the Companies Act, 2013 and the Rules made thereunder.

Directors and Key Managerial Personnel in attendance

Mr. Narendra Sanghvi, Mr. Sunil Lulla Directors of the Company and Dr. Vijay Aggarwal, Chief Executive Officer, Mr. Laxmi Rathi, Chief Financial Officer and Ms. Kruti Shah, Company Secretary of the Company had joined the meeting through Video conferencing from their respective locations.

Representatives from Statutory Auditors i.e. M/s. B K Khare & Co. Chartered Accountants and Secretarial auditors i.e. M/s. N K M & Associates, Company Secretaries attended the meeting through video conferencing.

5 Members attended the meeting through VC.

Mr. Narendra Sanghvi Chairman took the chair and Dr. Vijay Aggarwal, Chief Executive Officer ("CEO") commenced the proceedings of the meeting ascertaining that the requisite quorum was present.

The meeting commenced at 2.05 p.m. (IST) and concluded at 3.00 p.m. (IST) (including time allowed for e-voting at AGM).

The CEO welcomed all the members and other attendees for the meeting. He briefed the Members regarding the arrangements made for the meeting.

The CEO mentioned that the Annual Report for the year ended 31st March 2024 along with the Notice of AGM, Directors' Report and audited Annual Accounts (Standalone & Consolidated) have already been circulated through electronic mode to those members, who were holding shares of the Company as on cut-of date i.e. 30th August 2024 and whose e-mail IDs were registered with the Company/ Depositories and the same was taken as read.

It was further informed that the Members were provided with the facility to exercise their right to vote by electronic means, through remote e-voting and e-voting at the AGM in accordance with the provisions of the Companies Act, 2013 and SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015. He informed them that the members who have joined the meeting through VC and who had not cast their vote through remote e-voting, were provided the option to vote through e-voting facility made available at the AGM. The Company had appointed M/s. N K M Associates, Company Secretaries, as Scrutinizer to supervise the e-voting process and to provide combined voting results of remote e-voting and e-voting at the AGM along with the Scrutinizers Report.

The CEO on behalf of Company and Board delivered his speech to the members.
