ORDER

Heard the submissions made by the Ld. Counsel on behalf of the Petitioner. Ld. Counsel on behalf of the RD is present and submitted that they have already submitted their submissions which are recorded in order dated 20.11.2024 and they have no further submissions to be made. Ld. Counsel on behalf of the Income Tax Department is present and submitted that they have filed the report which is available on e-portal. They have no specific objection. No one is present on behalf of the SEBI, National Stock Exchange and Bombay Stock Exchange. However, Ld. Counsel on behalf of the Petitioner drew our attention to the additional documents filed by them in compliance of the order dated 20.11.2024 in which they have stated the legal position regarding

Sachin 08.01.2025 requirement of no objection from SEBI, National Stock Exchange and Bombay Stock Exchange. Ld. Counsel also submitted that since the wholly owned subsidiary is being merged with the parent company, in terms of Regulation 37(6) no prior specific prior approval of the SEBI is required. However, they have already given intimation to the National Stock Exchange and Bombay Stock Exchange which is available on the e-portal. Order in this matter is **reserved**.
