- Sub: Email received from BSE Limited and National Stock Exchange of India Limited (together, the "Stock Exchanges") each dated December 5, 2024 seeking clarification with respect to certain media report published on December 5, 2024
- Ref: Clarification on news item appearing in media reports under regulation 30(11) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

Dear Madam / Sir,

This is in connection with the clarification sought by the Stock Exchanges regarding the media report titled 'Power regulator questions transfer of Azure's 2,333 MW share to Adani Green Energy Limited' on the website 'https://economictimes.indiatimes.com/' published on December 5, 2024 ("**Press Report**").

In this regard, we wish to state that as a part of regulatory requirement, Solar Energy Corporation of India Ltd. ("**SECI**") had filed a petition before the Central Electricity Regulatory Commission ("**CERC**") in April 2024. Vide this petition, SECI had placed on record the power purchase agreements for 1799 MW executed in December 2023 and for 534 MW executed in March 2024 between SECI and relevant subsidiaries of Adani Green Energy Limited ("**Company**") as well as the supplemental power sale agreements executed in December 2023 and March 2024 between SECI and AP Discoms and Government of Andhra Pradesh. These agreements were executed subsequent

to CERC's order dated April 2, 2022, wherein the tariff was adopted by CERC for a total of 8,800 MW power, to be supplied to various states. CERC order is awaited in this regard.
