Patna to get 2nd civilian airport

Twenty-four years after the first terminal was inaugurated at the time of the Bihar-Jharkhand bifurcation, the Centre on Friday gave a green light for a second civilian airport.

Rare-murder of Dalit girl kicks up storm in Bihar

Minor's Body Found On Aug 12; Accused Yet To Be Arrested



Police registered an FIR against Sanjay Rai (45), whom the teen's family identified as the main accused, and five others on Thursday for gang rape and murder, in addition to charges under SC/ST Act.

Even as the firestorm of protest over the Kolkata doctor's rape and murder rages on, an equally horrific gang rape and murder of a 14-year-old Dalit girl in Bihar's Munger district has kicked up a storm in the state.

The girl's mutilated body was found near a pond in her village on Aug 12, but five days on, police were yet to arrest the person named as the main accused by the victim's family, or any of his five accomplices.

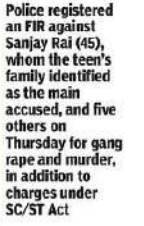

charges under SC/ST Act. Cops have detained one person and found a blood-stained 'kurpy' (a sharp tool used for digging) at the crime scene. Further investigation was on, police said.

The girl's mother lodged a police complaint alleging she was abducted from home at gunpoint on the night of Aug 11, brutally gang-raped and murdered by Rai, a fellow villager belonging to a dominant caste, and five of his un-

known associates. The minor's mutilated body bearing dozens of injury marks and signs of brutality was discovered the next morning.

"There were injuries on her face, neck and left hand, but there was no injury on her private parts, as reported by local media and social media platforms," Munger district SSP Babesh Kumar said.

"The doctors have not confirmed rape in the post-mortem report. However,

the viscera sample has been preserved for further investigation," the SSP added.

Kumar said Rai fled the village with his family after the incident. The person who helped him escape had been detained and was being interrogated, he added.

According to the FIR, the girl's mother alleged that Rai, who was already married had three children aged above 20 years, wanted to marry her minor daughter.

Just a day before the crime, he had threatened the family for turning down the proposal.

The SSP said call records showed the accused was in touch with the girl and her family and 420 phone calls were made between them.

The girl's older sister was also in touch with the accused and had talked to him even on the day of the crime. She was not cooperating with police in the investigation, the SSP claimed.
