We wish to inform that the Nomination and Remuneration Committee, in its meeting held on Thursday, December 12, 2024 has inter-alia:

- 1) Approved the allotment of 55,000 equity shares of ₹ 1 each to the Grantees, upon exercise of 55,000 options pursuant to the ESOS-2020 Scheme. The said shares shall rank pari-passu with the existing equity shares of the Company in all respects.
 - Upon such allotments, the equity shares capital of the Company stands increased from 19,93,84,176 to 19,94,39,176 equity shares of ₹1 each.
 - The statement pursuant to Regulation 10(c) of the SEBI (Share based Employee Benefits and Sweat Equity) Regulations, 2021 is provided in 'Annexure A'
- 2) Noted the forfeiture of 18,334 stock options granted to a Eligible Employee under ESOS-2020 Scheme, who have not exercised the vested options.



3) Approved granting of 3,70,000 (Three Lakh Seventy Thousand only) Stock Options to Eligible Employees of the Company under the ESOS-2020 Scheme, the details of which are provided in **Annexure B.** The Stock Options granted are governed as per ESOS-2020 Scheme, which was submitted with the Stock Exchanges at the time of obtaining the in-principle approval.
