<u>Subject: Outcome of Board Meeting & Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.</u>

Pursuant to Regulation 30 and other applicable provisions of the Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations") read with circulars / notifications / directions issued if any, and in connection with our prior intimation dated August 16, 2024, we wish you that the Board of Directors ("Board") of the Artificial Electronics Intelligent Material Limited ("Company") at its meeting held today i.e. August 21, 2024 has considered and approved the following:

 increase the authorized share capital of the Company and consequent alteration of capital clause of Memorandum of Association

To increase the existing authorized share capital of the Company from ₹ 15,00,00,000/- (Rupees Fifteen Crores only) divided into 1,50,00,000 (One Crore and Fifty Lakh) Equity Shares of Face Value of ₹ 10/- (Rupees Ten Only) each to ₹ 100,00,00,000 (Rupees One Hundred Crores only) divided into 10,00,00,000 (Ten Crores Only) equity shares of face value of ₹ 10/- (Rupees Ten Only) each by creating additional 8,50,00,000 (Eight Crores Fifty Lakhs) equity shares of face value of ₹ 10/- each, aggregating to ₹ 85,00,00,000 (Rupees Eighty-Five Crores only) and alteration in the Capital Clause of Memorandum of Association, subject to necessary approval of the Shareholders of the Company.

Furthermore, Clause V of the Memorandum of Association shall also be substituted with new clause V as follows:

"V. The Authorised Share Capital of the Company is $\not\in$ 100,00,00,000 (Rupees One Hundred Crores only) divided into 10,00,00,000 (Ten Crores Only) equity shares of face value of $\not\in$ 10/- (Rupees Ten Only) each. The Company shall have the power to increase and reduce the Capital of the Company and to divide the Shares in the Capital for the time being into several classed and to attach thereto respectively such preferential rights, privileges or conditions as may be determined by or in accordance with these regulations of the Company and to vary, modify or



abrogate any such rights, privileges or conditions in such manner as may for the time being be provided by the Company."

create offer and issue and allot Equity Shares on a preferential basis subject to approval of members.

The Board of directors of the Company has decided to drop the decision which were taken in the previous board meeting held on July 06, 2024 relating to raising of funds for an issue up to 9,00,00,000 No. of shares (Nine crore) through issuance of equity shares/ convertible warrants of the Company ("Equity Shares/ Convertible warrants") or any other Equity linked Securities of the Company or other securities convertible into or exchangeable for Equity Shares by way of Preferential issue.

However, Board has considered and approved the following;

To create, offer, issue and allot up to 2,23,10,000 (Two Crore Twenty Three Lakh Ten Thousand) fully paid-up Equity Shares of the Company having face value of ₹ 10/- each, at a price of ₹ 18/- (Rupees Eighteen Only) per Equity Share, including a premium of ₹ 8/- (Rupees Eight Only) per Equity Share, aggregating to ₹ 40,15,80,000 (Rupees Fourty Crores Fifteen Lakhs Eighty Thousand Only) on a preferential allotment basis to Promoter, Promoter Group and Non-promoter as per the provisions of the SEBI (ICDR) Regulations, 2018 as amended time to time. This issue & allotment is made pursuant to and in accordance with the provisions of the Companies Act, 2013 read with rules made thereunder and Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations") and other applicable provisions, if any and subject to approval of Shareholders and other regulatory authorities, if any.

The Board has approved the Valuation Report Issued by Mr. Vasudevan. S (Registration No: IBBI/RV/05/2019/11704), Registered Valuer for the purpose of issue of equity shares on preferential basis.

The details in respect of the Preferential Issue, as required to be disclosed under Regulation 30 of the SEBI LODR Regulations, read with the SEBI Circular No. SEBI/HO/CFD/CFD-PoD1/P/CIR/2023 on disclosure of material events/ information by listed entities, dated July 13, 2023 ("SEBI Disclosure Circular") is set out below at Annexure – I

The proposed issue will be undertaken in accordance with the provisions of Chapter V of the SEBI ICDR Regulations, and any other applicable rules / regulations / guidelines, if any, prescribed by any other regulatory of statutory authorities.
