We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of GITA RENEWABLE ENERGY Limited ("the Company") for the Quarter ended September 30, 2024 and year to date from 1st April 2024 to 30th September 2024 (hereinafter referred to as the "Statement"), attached herewith.
