Ahmedabad. Many stroke patients experience early signs that they do not take seriously. There are two main types of strokes. An ischemic stroke that creates a blood clot, or thrombus, blocks an artery. The other stroke is the Hemorrhagic stroke in which a blood vessel bleeds uncontrollably inside the brain. Stroke increasing among younger adults. Among those aged 18-44 years old there was a 14.6% increase in stroke prevalence; for adults in the 45-64 category, it increased by 15.7%. There is a notable increase in premature atherosclerosis, which involves the hardening and blockage of blood vessels, particularly among younger adults.
