#### **Bourbon** bottles signed by Pope for charity funds

Rev. Jim Sichko, a Kentucky-based Roman Catholic priest, saw an opportunity to turn a signature Kentucky product, and his access to Pope Francis as a papal missionary of mercy, into a way to help those in need by auctioning off bourbon bottles signed by the Pope. His unconventional idea raised about \$30,000 when Sotheby's auctioned off two bottles signed by the Pope, plus another bourbon bottle autographed by former Super Bowl-winning quarterback Tom Brady. The proceeds are being divided among organizations selected by Sichko. The Catholic Diocese of Lexington, where Sichko is based, will use some of the money to help people in need.

#### No review of sentence to UK teen

The attorney-general for England and Wales, Richard Hermer, has rejected calls to request a court review of the length of a jail sentence imposed on the British teenager who killed three young girls at a Taylor Swiftthemed dance event last summer. Axel Rudakubana, 18, admitted killing the girls and stabbing 10 others last July in the northern town of Southport, an atrocity that shocked Britain and was followed by nationwide rioting. He was sentenced to at least 52 years behind bars last month. He is unlikely ever to be released.

#### PAKISTAN 4 dead as van overturns

At least four people lost their lives, and ten were injured when a van carrying pilgrims overturned in Nawabshah, ARY News reported. The accident occurred on Amri Road when the speeding van, en route to Sehwan Sharif, lost control and overturned. Rescue teams arrived at the scene, and police confirmed that the deceased and injured had been transported to a nearby hospital. Authorities have yet to determine the exact cause of the accident, but initial reports suggest that the driver may have been speeding. The identities of the victims have not yet been disclosed.

# European army for Europe, says Zelenskyy

MUNICH

Ukrainian president Volodymyr Zelenskyy said on Saturday that "time has come for an European army to be created" and that his country's fight against Russia has proved that a foundation for it already exists. Addressing the Munich Security Conference, Zelenskyy said Europe cannot rule out the possibility that "America might say no to Europe on issues that threaten it", and noted that many leaders have long spoken about how Europe needs its own military.

"I really believe that time has come," Zelenskyy said. "The armed forces of Europe must be created." All the weapons should be fully produced in Europe. He added, "Europe must decide its own future." "If this (Ukraine-Russia) war ends the wrong way, he (Putin) will have a surplus of battle-tested soldiers who know nothing but killing and looting," he warned, citing intelligence reports saying Russia will dispatch its troops to Belarus this summer. "And now, as we fight this war and lay the responsible for it.

### Mob attacks senior UN peacekeeper

The United Nations peacekeeping force in Lebanon says its outgoing deputy commander has been injured after one of its convoys was

'violently attacked". The UN Interim Force in Lebanon (Unifil) said in a statement that the convoy was taking peacekeepers to Beirut airport when it was targeted and one of its vehicles set on fire. Protesters have been blocking the road to the airport following a decision by the Lebanese government to bar two Iranian planes from landing.

Both Lebanon's President Joseph Aoun and the country's army condemned the attack on Unifil, and said they would work to arrest those involved. Several videos shared online show one white UN vehicle alight, as a group of young men, carrying yellow flags, chase and beat what appear to be peacekeepers as they attempt to flee. Separate footage shows a group of men shouting as they kick, hit and climb onto a convoy of three

UN vehicles along a dark road. Unifil's injured deputy commander, who was not named, was returning home after ending his mission, according to a statement from the United Nations.

Scholz lashes out at Vance's 'scolding'

MUNICH

A day after US Vice-President JD Vance scolded European leaders over their approach to democracy at the Security Conference here, German Chancellor **Olaf Scholz** shot back strongly in defence of his stance against the far-right and said his country won't accept people who "intervene in our democracy". The German leader spoke just eight days before crucial elections in Germany, with polls showing the far-right Alternative for Germany (AfD) party currently in second position in the race to the hustings.

Vance said on Friday at the Munich Security Conference that he fears free speech is "in retreat" across the continent. "Germany is a very strong democracy, and as a strong democracy, we are absolutely clear that the extreme right should be out of political control and out of political decision making processes, and that there will be no cooperation with them," Scholz said. "We really reject any idea of cooperation between parties, other parties and these extreme right parties."

Scholz said "free speech in Europe means that you are not attacking others in ways



that are against legislation and laws we have in our country" He was alluding to rules in Germany that restrict hate speech, reports the AP.

conservative opposition leader Friedrich Merz on Saturday joined his domestic political rivals in condemning US President Vance's attack on Europe's stance toward hate speech and the far right, reports Reuters.

"We stick to the rules imposed by our democratic institutions," Merz said in a panel discussion at the Munich Security Conference. Polls show his conservative bloc in the lead ahead of general elections in Germany on 23 February.

Germany is a staunch defender of freedom of speech "but fake news and hate speech remain subject to legal restraints", he added.

# 3 Israeli hostages set free Anger, chaos over mass federal layoffs

CAIRO/JERUSALEM

Israeli hostages Iair Horn,46, Sagui Dekel-Chen, 36, and Sasha (Alexander) Troufanov, 39, arrived at a release site in Gaza on Saturday after Egyptian and Qatari mediators helped avert a standoff that threatened to sink a fragile ceasefire. The three were led onto a stage with Islamist militants armed with automatic rifles standing on each side of them at the site in Khan Younis, live footage showed.

The three are being returned in exchange for 369 Palestinian prisoners and detainees, a swap which eases fears that the agreement could become known as Hostage Square in Tel Aviv, people broke into cheers and tears when they heard the Red Cross was on its way to deliver the three to Israeli forces in

## NEW YORK

Workers across the country responded with anger and confusion Friday as they grappled with the Trump administration 's aggressive effort to shrink the size of the federal workforce by ordering agencies to lay off probationary employees who have yet to qualify for civil service protections.

While much of the administration's attention was focused on disrupting bureaucracy in Washington, the broad-based effort to slash the government workforce was impacting a far wider swath of workers. As layoff notices were sent out agency by agency, federal employees

from Michigan to Florida were left reeling from being told that their services were no longer needed.

In a sign of how chaotic the firings have been, some who received layoff notices had already accepted the administration's deferred resignation offer, under which they were supposed to be paid until September. 30 if they agreed to quit, raising questions about whether others who

signed the deal would nonetheless be fired. On Friday evening, the Office of Management Personnel (OPM), which serves as a human resources department for the federal government, acknowledged that some employees may have received termination notices in error and said the buyouts agreements would be honored. "This has been slash and burn," said Nicholas Detter, who had been working in Kansas as a natural resource specialist, helping farmers reduce soil and water erosion, until he was fired by email late Thursday night. He said there seemed to be little thought about how employees and the farmers and ranchers he helped would be impacted.

# 'You can't drive us apart'

Fox News to air Trump-Musk interview on Feb 18

WASHINGTON

In an exclusive joint interview set to air on FOX News on February 18, US President **Donald Trump** has panned attempts by the media of trying to create tension between him and the billionaire DOGE chief Elon Musk and said the efforts are not working. The interview with FOX News Channel's Sean Hannity will also cover other topics such as Trump's first 100 days in office and major ongoing news stories.

In a sneak preview of the interview airing on FOX News on February 18 at 9:00 pm ET, and released by FOX News on Friday, Trump discusses how the media's efforts to separate him from Musk are ineffective.

In a video published by FOX News on its YouTube channel Trump said, "I see it all the time... Actually, Elon called me, you know they are trying to drive us apart. I said absolutely." He added, "We have breaking news, Donald Trump has ceded control of the presi-

dency to Elon Musk. President Musk will be attending a cabinet meeting at 8:00. And I say it is just so obvious."

He further said, "They are so bad at it. I used to think they were good at it. They are actually bad at it... I think nobody in history has ever gotten more bad publicity than me. I could do the greatest things. I get 98% bad publicity." The New York Post in a report said that the 47th President, speaking in a television news anchor's cadence, parodied some of what he's heard about himself and Musk

on the news. "You know, they said, 'We have breaking news. Donald

Trump has ceded control of the presidency to Elon Musk. President Musk will be attending a cabinet meeting tonight at 8:00," Trump joked. He blamed the media for attempting to drive a wedge between his relationship with Elon Musk, the head of Department of Government Efficiency (DOGE). Elon Musk will address the traditional media's attempts to portray a rivalry between them. A few days back, Musk, accompanied by his four-year-old son X, was seen in the Oval Office alongside Trump as the latter signed an executive order to continue downsizing the federal workforce.
