SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, the timeline as specified in sub-para 7C of Para A of Schedule III states that in case of resignation of key managerial

personnel, senior management, compliance officer or director other than an independent director; the letter of resignation along with detailed reasons for the resignation as given by the key managerial personnel, senior management, compliance officer or director shall be disclosed to the stock exchanges by the listed entities within seven days from the date that such resignation comes into effect.

Hence, the intimation was given to the Exchange within three days of the effective date of resignation along with the resignation letter. We would like to submit that we have noted the contents of SEBI Circular dated 13th July, 2023 and shall be vigilant going forward.

We would like to submit that this was an inadvertent act and request you to condone the same.
