In compliance with the provisions of Section 108 and 110 of the Companies Act, 2013 and Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided to its Members the facility of remote e-voting platform of M/s. KFin Technologies Limited to cast their votes on the Resolution proposed in the Postal Notice dated 28th May 2024.

The Board of Directors of Deccan Cements Limited on 28th May 2024 appointed me as the Scrutinizer for conducting the Postal Ballot process through voting by electronic means (evoting), to accord the consent of the members of the Company by Special Resolution as mentioned in the Postal Ballot Notice dated 28th May 2024.

The Company had on 11th June 2024, completed the dispatch of the Notice of Postal Ballot along with the Explanatory Statement through Email, as prescribed under the provisions of the Companies Act, 2013, and applicable SEBI regulations to all its Equity Shareholders whose name(s) appeared on the Register of Members / List of Beneficial owners as on the cut-off date, i.e., 7th June 2024, and to all the Directors, Auditors of the Company.



- 2. The Postal Ballot process has been conducted in accordance with the provisions of Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 [including any amendment(s) / modification(s) / reenactment(s) thereto]. The Company had provided remote E-voting facility to its Shareholders and had engaged the services of KFintech for this purpose.
- 3. The voting through remote E-Voting had commenced on 12th June 2024, Wednesday @ 9:00 A.M. (IST) and had ended on 11th July 2024, Thursday @ 5:00 P.M. (IST)
- 4. After the time fixed for closing of the E-Voting process, i.e., on 11th July 2024, Thursday @ 5:00 P.M. (IST), I had downloaded the data of E-voting from KFintech. The Report was tabulated and the data reading the final E-voting was diligently scrutinized.
- 5. The Particulars of Electronic votes cast by the Equity Shareholders have been entered in the electronic register separately maintained for the purpose.
- 6. The Votes cast through E-voting were scrutinized and the shareholding was matched / confirmed with the list of Beneficial Owners, as on the cut-off date, Friday, 7th June 2024.
- 7. All e-votes cast up to 5.00 p.m. on Thursday, 11th July 2024, being the last date and time fixed by the Company were considered for scrutiny.
- 8. On proper scrutiny of all E-votes, the summary of the E-Votes cast by the Shareholders was prepared and the same is given in the Annexure annexed with this Report.
- In respect of the resolution, since the votes cast FOR the resolution is more than three times the number of votes cast AGAINST the Resolution, the Resolution is considered to be duly passed by requisite majority.
- 10. The relevant records were sealed and handed over to the Company Secretary for safekeeping.
