We did not review the interim financial results of subsidiary and associate included in the statement, whose financial information reflects total revenue of Rs. 6.42 lakhs and Rs. 6.42 lakhs, total net profit after tax of Rs. 3.19 lakhs and Rs. 4.51 lakhs, total comprehensive profit of Rs. 3.19 lakhs and Rs. 8.76 lakhs for the quarter and nine months period ended on 31st December, 2024, respectively as considered in the Statement.
