“Sub: Clarification for the intimation submitted by the company for the Completion of tenure of Independent Director of the Company Under Securities and Exchange Board Of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

Dear Sir/Madam,

As informed earlier that Hon’ble Adjudicating Authority, i.e., National Company Law Tribunal, Chandigarh Bench admitted the Company Petition i.e. C.P. (IB) No. 291/Chd/Chd/2018 filed by the Financial Creditor, Edelweiss Asset Reconstruction Company Limited, on 22.12.2023, initiating Corporate Insolvency Resolution Process under Insolvency & Bankruptcy Code, 2016 (hereinafter referred to as “Code”) against M/s Winsome Yarns Limited (“Corporate Debtor”) and appointed Mr. Sanjay Gupta as the Interim Resolution Professional. Thereupon the members of the Committee of Creditors (“CoC”) in its meeting has approved appointment of M/s ARCK Resolution Professionals LLP, Insolvency Professional Entity, as Resolution Professional in place of erstwhile IRP. The appointment of M/s ARCK Resolution Professionals LLP, Insolvency Professional Entity, was confirmed as Resolution Professional vide Order of Hon’ble NCLT passed on 14.03.2024.

Since initiation of CIRP, the powers of the Board of Directors are suspended and vests with the IRP/RP as per the provisions of Section 17 and Section 23 of the Insolvency and Bankruptcy Code, 2016. As the powers of the board are suspended since from the initiation of the CIRP and intimation for the completion of 5 years tenure of the Independent Director named Mr. Tilak Raj Dembla (DIN:-02605451), within 24 hours has been inadvertently left out and the same was intimated immediately as when the same came to the knowledge.
