Sub: Outcome of Nomination, Remuneration and Compensation Committee Meeting.

This is to inform you that the Nomination, Remuneration and Compensation Committee (NRC) Committee of the Board in its meeting held on 30th January, 2025 has inter alia transacted the following business:

- 1. Approved grant of 49,000 Stock Options under Employees Stock Option Plan 2018 (ESOP 2018 Scheme) to the identified employee of the company on the terms and conditions as placed before the NRC Committee Meeting.
- 2. Approved allotment of 4,000 Equity shares of Rs.10 each under Employees Stock Option Plan 2007 (ESOP 2007 Scheme) to an employee of the company who exercised the stock options, on the terms and conditions as placed before the NRC Committee Meeting.
